

WARRANTY DEED

WITNESSETH: That for the FULL AND VALUABLE CONSIDERATION in the amount of Four Hundred Fifty Thousand Dollars and No Cents (\$450,000.00), the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby conveys a fee simple estate with covenants of GENERAL WARRANTY to the Grantee(s), to hold as joint tenants with remainder in fee simple to the survivor of them, in and to the following described real property, together with all improvements, located in Jefferson County, Kentucky, to wit:

Being Lot 5 and the northwesterly 15 feet of Lot 6, Block "A", as shown on plan of Rolling Fields, a plat of which is of record in Plat and Subdivision Book 9, Page 81, in the Office of the Clerk of Jefferson County, Kentucky; being known and designated as 429 Swing Lane.

Being the same property conveyed to The Ann O. Kirk Revocable Trust, as amended and Restated on November 2, 2011, by Ann O. Kirk, as Settlor and E.T. Kirk, as Successor Trustee, by deed dated 11/02/11, and recorded 11/10/2011, of record in Deed Book 9797, Page 0793, in the office of the clerk Jefferson County, Kentucky.

The Grantor further covenants that it is lawfully seized of the estate hereby conveyed; that it has full right and power to convey same; and that said property is free and clear of all encumbrances.

PROVIDED, HOWEVER, there is excepted from the foregoing warranty and covenants of title, and this conveyance is made subject to, any existing stipulations, easements, restrictions of record, and zoning regulations for Jefferson County, Kentucky, affecting said property, and the state, county, school, special district and any city taxes, which taxes have been prorated between the parties, with the Grantees to assume and pay all future tax bills.
