countries. Kentucky 770 gun deaths every year, rate of 17.1 deaths per 100,000 people. Kentucky 14th highest rate of gun deaths in the U.S. cities are working to enter the senseless

violence. Protecting public safety is government's highest responsibility. Support for the second

amendment

rights of law abiding citizen goes hand in hand keeping guns away from people with dangerous histories.

Whereas mayors and law enforcement officers and are best positioned to understand how to keep their citizen safe.

Whereas gun violence prevention is more important than ever as the Covid-19 pandemic continues to exacerbate increased calls to

suicide and domestic hot lines. Anyone can join this campaign pledging to wear orange June 3rd, first Friday in June in

I have had firsthand knowledge of having incarcerated parent. The effects it has on young children. Effects, social, emotional and cognitive development. This is such a big issue "Seasame Street" has created programs to help them move

through these '{U}s. Not saying we should not hold people accountable, however we know African-American men make

up majority of our population in our jail and no secret in too many instances also receive stronger sentences.

We want to help children and families stay connected to incarcerated loved one. I place emphasis on children.

We know -- burden of these calls fall on the women. Mothers, grandmothers and sisters.

These calls are very expensive and places further financial burden. Louisville metro council on behalf of marginalized families we urge you to please make three phone calls happen. We have been talking about this

issue for several years now. We know you can. You have the authority and power to make it happen.

The other burden that continues in our community in-person visitation as not reopened. These families need person to

person contact especially for the children. We need spaces to be clean, healthy and space. I once worked for a program that served low income communities. XHEK TIF executive families just because we serve them doesn't

mean they have to look poor. We hope there will be immediate action to address these two important issues.

I leave with scripture Micah 8:10 new living translation: Oh people, the lord told you what is good and this is what he

requires of you, each one of you. To do what right, to walk humbly with your God.

Please Louisville council. Please do what is right and what is good. >> Raphaella plateaued.

>> Thank you for having me. Wonderful to be in this hall and SMEEK speak to one sending messages back and forth, thank

you Pippy Raymond for your great service tonight. I am here on behalf of the art museum and our board.

I am the director. I have already had the pleasure to talk to some of you about the part we are shaping.

I am here we did put proposal together for our funding. Hope you will consider that. We have started fundraising

process it is an 18 million dollar budget. It would be incredibly meaningful to this park if there were city support. I think you know more than others how important it is to spend time in nature. How peoplely nourishing. Thank you for your consideration. >> Thank you.

Nick Clark. >> Hello, I know I have met or spoken with some of you recently.

Thank you for allowing me to speak to the whole council. My name is Nick Clark. I am here to address safety in

our clubs. My husband was murdered by a bouncer. Christopher never got justice

because of their negligence. City doesn't care and we are left with pain and agony in our hearts.

I have spoke to you about Christopher's law bouncers receive deescalation and interpersonal communication and

more. Many bars hire by word of mouth, physical stature and social media.

Wouldn't you want there to be safety measures in place where anything could happen. Bouncer abuse happens everyday

believe it or not. Just Google it. When your child and loved one goes to a bar, wouldn't you want them to -- it is a no brainer. Two years and four months I have been trying to make a change with our bar scene.

Bartenders do not have to be trained how to serve alcohol and Christopher's law drafted by county attorney's office.

For something so simple I don't understand why this can't be implemented. It would be the bouncer's

responsibility to pay for the training they receive which is minimal. Hardly requires any time and money. Just like our military, police force, firefighters, teachers have to have training.

I am no stranger to the bar scene. Two bartenders doing shots at big bar.

I have a friend that got a job and they had to do two shots. Partner with me on Christopher's law.

Violence, drug and crimes is not going to get better. I understand best practices, they are not mandatory for bars

to follow. I plan to reach out to some or all of you to discuss how we can get Christopher's law off the

ground 270-307-2249. Thank you for all of y'all's time and for listening. >> Thank you.

[INAUDIBLE] Clark. >> My name is Kenny Clark. I am speaking on behalf of my son-in-law, Christopher McKenny

killed nowhere bar 2020. Christopher was the kindest and most loving thoughtful human being and our family is heart

broken. We are on a mission to honor his name and memory by enacting Christopher's law requiring

bouncers to receive training and certification relating to their jobs to prevent another tragedy from happening in our city

again. Relating to untrained overaggressive bouncers are common place.

April 2022, taboo lounge in Philadelphia, bouncer punches a patron in the head. A bouncer kicks a 20-year-old

man in the head as he is being helped up in springfield, Missouri. June 2021, California, redwood city wine bouncer kicks patron in the head hits him in the flashlight. Bouncer hit as a patron resulting in his death. Just a few examples involving bouncers I did with a quick Google search. This absolutely independent Kated some regulations and training involving bouncers is needed.

Many states and cities have laws regulating bouncers. In Georgia bouncers have to have training to diffuse safely, how

much force, when to call police and how to inspect ID's and identify intoxicated individuals.

Security personnel required to handle tense situations and identify when a person is too intoxicated to be served.

California mandates bouncers complete 16 hours of job specific training. Pennsylvania bouncers receive

training course identifying problem pray tons best practices for safe removal of a problem patron without physically

harming them or others. Requiring bouncers will make it safer in an alcohol-driven environment. Also helping owners to mitigate liability and lower insurance premiums. In close I would like to invite

one or more councilmembers enacting Christopher's law. >> Thank you. Patricia RAMy.

>> I am here today representing thousands of members of citizens concerned about insufficient availability in Louisville.

I don't have to remind you Stark numbers 72,000 individuals no or inadequate housing options. It is beyond the capacity of the

human mind to comprehend these numbers. We must remember they are not just numbers they are people,

they are families, seniors, veterans, mothers, cousins children. It is incomprehensible for us to understand devastating effect of poor housing on the lives of children. Ability to learn, development,

thrive. Every year every night an as many as 5,000 children are home less living in shelters. Sleeping on the couch, floor, car. We at clout are thrilled the American rescue plan allowed Louisville to invest 40 million dollars in the affordable housing trust fund. Across the United States have

proven to be the most effective ways to provide funding that makes it difficult be it new apartment complex Oren or

renovating homes. Make sure you continue the annual -- affordable housing must remain a priority.

Much like we fund city infrastructure. Housing is foundational for families and cities.

That said, once more, let me say it is necessary to fund the trust fund at its full ordnance defined level of 10 million

dollars. This year, every year. Good steps taken to make real changes happen.

Let's keep that progress going. >> Thank you. Jonathan Berkeley. >> Hello, my name is Jonathan

Berkeley. I am a member of the Baptist church. I am chair of the research

committee. My family has a personal experience with the city gun crisis.

Six years ago my grandson was in a car with friends and someone came up to the car and shot his friend.

Involved in a petty disagreement. My grandson in the car. >> City wide listening process last fall involved nearly 400 members of the community. That is why clouts members voted for crime and gun violence be

our new area of focus for this coming year and beyond. Our research that followed, we had 22 meetings, local

professionals, officials, and service providers related to this problem area. Every meeting, officers safe and

healthy neighborhoods came up as most critical in Louisville to address this gun violence crisis.

Our community needs response to immediate crisis at hand and work proactively to end it.

Officers safe and healthy

neighborhood doing just that. That is why funding this year in the future critical. This is a problem that has taken

root and take time to solve. Unfortunately we haven't seen negative repercussions giving programs time to work.

Can't make that mistake again. Collaborative with the community. Clout included to address this problem of crime and violence. I have 12 grandchildren. I want our children to be safe from gun violence.

Isn't that what we all want. >> Thank you. Maria Martin. >> I have lived in Louisville since 2005. I moved here from Rochester, New York. [INAUDIBLE] claim to be Denise Murphy in one way shape or form. I go by Denise. There is Denise perkins Murphy. One used a maiden name I had

which was mills. I got married again. It was a short marriage, we were divorced.

I am not sure what happened. December 2018, I tried to report theft of money, 800 off my direct express account.

I was told by officer Pierce I would get my money back and untrue. He refused to make a report on

social security card being gone and license. In general, July, my vehicle was stolen.

Why wouldn't I bring it home? Doesn't make sense. Subsequently sold my vehicle at auction.

Vehicle still registered in my name. I have six false police reports. I was evicted from my home.

I have been charged with things are absurd. Should be thrown out. I was approached on a street by

a woman named blue who slapped my phone if I didn't stop I would be raped then my granddaughter.

One has come true. It was put on porn hub. I watched it because they made me.

I have told three judges, 16, 17 Louisville metros who laugh or walk away. The report says they came for a

report of trouble and that they were approached by me. That is it. His report says.

He was assaulted. I read the reports again I can't make sense out of them. The man walked up to me, I need

to be mindful of my singing, stop being so loud. Stop listening to my music, if people didn't want me here. I

would just move. They said I was uncooperative and would not follow through. I have three papers that say

officers or detectives took over. >> I am so sorry your time is up.

- >> My time is not up. >> People have been up here. >> I hope when they kill me you all were paying attention.
- >> Kim DAR. >> Thank you, I am with Kentucky interface power and light and remember of renewable energy

alliance of Louisville. I teach environmental studies environmental justice at University of Louisville.

I have converted my house and car to 100% renewable energy and worked with students from Dupont manual to put solar panels on

their schools. It is my hope and dream to have solar panels on every JCPS. I want to thank you commitment

to move this community to 100% renewable energy by 2040. I want to thank you all for resolution 04522 you passed in

March of this year, establishing capital energy innovation fund where we take the money we save from energy efficiency, put it

into a fund to build new energy efficiency structure. Working on a new budget I would like to include three new things

if possible. First line item developing a plan that would lay out the steps, milestones, deadlines, responsibility and budgeting to meet those goals. Secondly, I would like to see additional seed money to fund

energy innovation fund so we can meet the goals we set in the resolution in the year 2020. Third, I would like to include

money in the budget to fund solar over Louisville solar grant program that helps low income residents facing high

energy burdens. Finally, I would like to invite you to join us online for virtual conference June 29th at

7:00. I will send each of you an e-mail invitation tomorrow. Speakers Janet Beacher and Alison Smith Louisville office of advanced planning and sustainability. They will be talking about ways

Undershoot or in the right spot. Any clarification needed? I have an amendment I would like to add it adds a No. 3.

Insuring adequate funds. This came out of a meeting generally supportive of this resolution. Issue they brought up is are current regulation require \$250 fee in lieu per tree. State requirement around 750.

They felt like 250 may not adequately cover the cost. I don't know what the right answer. Point is determine is 250 right? Should be 150, should it be 400. I would ask for your support. Happy to answer any questions.

Ultimately the goal to increase our tree canopy. Should be our long-term goal. Thinking of funding for trees.

Thinking of complete streets plans and how we line our roadways with trees or pedestrian.

We need a comprehensive look. However we want to balance that with not having wanted to add undo regulation already moving

through the process. and making sure we are not creating unintended consequences.

Would ask for your support. >> Thank you. >> Councilmember Hollander. >> I voted against this in

committee. I am going to vote for it tonight. I want to explain in part tree

removal fee probably needs to be increased. We think it ought to be studied. I am skeptical it should be

done. I thank you for letting me speak. >> Thank you councilmember

Hollander. >> Does this have a time in it? Without one planning commission tends to not come back in a

timely fashion. >> I don't believe. I am happy to entertain friendly amendment.

- >> Typically 60 days minimum. Anything above that, less than whatever you can tolerate is good.
- >> Travis, do we think 180 days might be reasonable? >> Assistant county attorney. Certainly could be.

What we generally advised on these KRS requires 60 days. Council can decide to hold their own public hearing.

Then make their own decision. not doing so won't prevent us from exercising our ability to bring it back in front of us, 60

day or 61 or day 600. If you would like a suggestion, I wouldn't call it strictly necessary.
