

This is Bernie, the social work practicum student at Rutherford Elementary School. It was great to see you at the Beechmont Neighborhood Association meeting on Monday! I apologize that I was unable to stay and talk to you that evening. I am emailing you to address a safety concern at Rutherford, and I have CC'ed Sheryl Day at her request.

On Monday, 03/14/2022, one of our students was hit by a car while crossing in the crosswalk with a crossing guard to get to the school building. It is my understanding that the driver drove off and was unable to be identified, and that law enforcement was contacted but they were ultimately unable to open a case. I do not believe that there are any flashing school-zone lights or other safety precautions around our school building, and I decided it would be best to contact you to see if the city has any ability to make the streets any safer for the students. Any thoughts would be appreciated.
