Council Members,

When hearing about the May 14 Top's Grocery Store massacre, I continued to listen for the same story background. It finally came, that the FBI / authorities were already tracking shooter Payton [S.] Gendron. Gendron was released from custody while undergoing psychiatric evaluation and allowed to purchase firearms. Here again, it was FBI negligence leading to these murders. Thus, I am calling for the resignation of **FBI Director Christopher Wray** for harboring this culture of willful FBI negligence. I demand Wray's termination. And pursuant to my April 9, 2021 letter to Sen. Mitch McConnell, posted on my websites, I demand an independent audit of FBI activities. It is apparent that the FBI is facilitating these mass shootings to influence public opinion on gun control.

Next, attached is my March 28, 2022 letter to Mayor Greg Fischer and the Metro Council explaining why **Kentucky House Bill 314**, now passed, was necessary for allowing Metro townships to incorporate. And at the April 19, 2022 mayor candidate's forum, I explained to the candidates that the next Louisville mayor will also fail unless stopping the Federal Reserve's three antitrust violations that is causing taxpayers to pay over 50% of federal taxes to the national debt. This depletion of the U.S. tax base is why there's not enough money to service the townships. Attached, Lines 5 & 8 in the *Taxpayer's Balance Sheet* shows we are headed for economic depression though President Biden and media propaganda are saying it will be recession due to inflation. The extreme debt, that forces borrowing, causes inflation. For here again, this is an avoidable debt crisis, along with the baby formula and next COVID crises, and Biden allowing Putin to destroy the Ukraine breadbasket to create food shortages. \* "Total taxes applied to U.S. budget" gets smaller every year while debt grows (see Item 5, above). This circular debt / constant borrowing is due to three antitrust violations by the Federal Reserve since 1999 (see fed. lawsuit 3:20-cv-298). Eventually, budget cannot sustain \$obligations, leading to economic collapse. –

- **Solutions: STOP the antitrust violations; replace Federal Reserve with "Office of Commercial Contracts" for commercial banks within U.S. Treasury Dept** (required by U.S. Constitution).

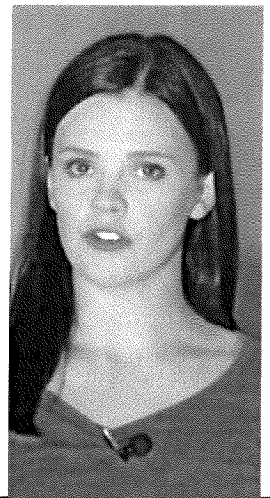
