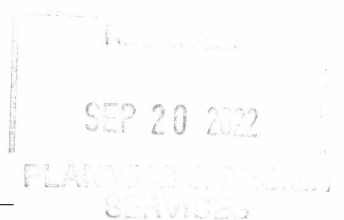
NO LOANING OR BORROWING. INCLUDING CIGARETTES and BEER.

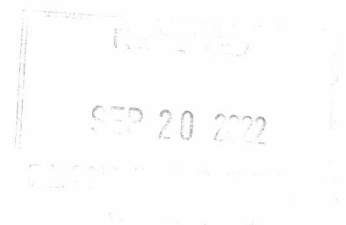

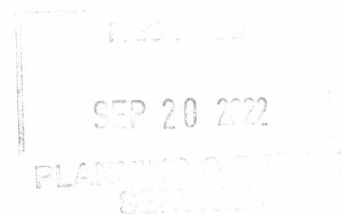
