The letter does not verify the accuracy of the petition, but only serves as acknowledgement that the petition was filed with Planning & Design Services.

Planning Commission,

Attached is a Petition with over 300 signatures of property owners requesting an evening public hearing of the Planning Commission associated with a proposed Concrete Batch Plant at 13905 Aiken Road (22-DDP-0098).

We believe this request is consistent with the spirit of the Louisville Metro ordinance related to an evening public hearing by the Planning Commission. More specifically:

- The proposed request for a Concrete Batch Plant adjacent to our neighborhood appears to us to be significantly more important (and more devastating) than a normal rezoning request.
- The proposed Concrete Batch Plant is proposed for an existing residential buffer area associated with an M-3 quarry use that has been maintained for 40 years adjacent to our neighborhood. In addition to replacing a buffer area with an industrial plant, the proposed Concrete Batch Plant would add large concrete trucks to a significant portion of Aiken Road, which we consider to be a narrow, residential, tree-lined roadway with schools, a church, and no sidewalks.
- And a proposed Concrete Batch Plant requires an APCD air quality permit, noting that there are only five other industrial facilities in eastern Jefferson County (north of I-64) whose emissions require an air quality permit. Three of these five existing air quality permits are located nearby on or near Avoca Road, which appears to be a more appropriate industrial-type, non-residential roadway. One of the other five existing air quality permits is for the Ford Kentucky Truck Plant. None of the five existing air quality permits is located adjacent to a major residential area, or has large trucks using a residentially-oriented roadway.
