See updated plan using a 4x12' long planter in lieu of the 6x8 existing size? Code Section 5.5.8.3C.1.a.II states that a 4'x4' tree volume minimum is required. We have made the planters along 7<sup>th</sup> and 8<sup>th</sup> the 4'x12' size which provides the required 5' clear pedestrian zone.






We received your note/concern on 720 West Muhammad Ali from Molly this morning regarding the sidewalk widths. See attached updated CAT3 plan that pushes our building to the south. This layout helps us with grading as well so that we can introduce a level terrace at the NW corner where our retail spaces are located. Otherwise, we would have varying heights of thresholds along Muhammad Ali which is not preferred and is costly having varying FFE's within the first floor.

For the streetscape we can install tree grates to provide the additional space needed for clear walk zones on Muhammad, 7<sup>th</sup> and 8<sup>th</sup>. I have made the notation on the attached plan. Adding the tree grates and pushing the building south gives us 6' of clear walking space along Muhammad at our tightest areas and 5' of clear walk zones on both 7<sup>th</sup> and 8<sup>th</sup> Streets. Clear walk zone dimensions have been added to each street frontage.

Please let us know if this solution resolves your concern.
