Thence S 22°17'58" E, 5.34 feet;

Thence with a curve to the left having a radius of 234.91' and a chord which bears S 45°36'53" W, 71.52 feet;

Thence leaving said R/W line N 35°47'47" W, 85.85 feet;

Thence S 54°08'43" W, 862.74 feet;

Thence N 35°48'30" W, 223.00 feet;

Thence N 54°21'36" E, 314.41 feet;

Thence N 31°21'59" W, 332.69 feet;

Thence N 54°11'10" E, 262.60 feet;

Thence S 31°29'36" E, 332.47 feet;

Thence N 54°16'33" E, 538.12 feet to the westerly R/W line of Herr Lane aforesaid;

Thence with said R/W line S 33°41'52" E, 192.64 feet;

Thence S 54°12'30" W, 3.37 feet;

Thence S 37°28'38" E, 98.30 feet to the point of beginning.
