We have more talent per square foot in this sport than in any other city in American. I'm convinced of that.

I brought my daughters when we moved here, they were 2 and a half years old, and I was a big soccer guy growing up. And so, of course, I rolled my girls in soccer and they were in the Catholic school system.

And I got absolutely hazed by all of my friends for why my daughters weren't playing volleyball.

And I didn't understand it until finally they hooked me.

And even this weekend, my family's heading out of town with thousands and really tens of thousands of other families to St. Louis of all places.

To play volleyball in a huge tournament of which these ladies are very familiar with.

I do want to take a minute a somber moment.

To acknowledge that actually, it was 2 it was 3 years ago.

2 days ago on valentine's day that we lost.

4 members of our volleyball community.

And Kerry and Casey McCall, Carrie was 44 years old. Casey was 12 years old.

Leslie and Ryan prefer.

Leslie was 40 and her daughter was 12 years old.

Who were killed, who was and Leslie was a member of our own local fire department.

Who were killed in a tragic car accident while heading to 1 of these tournament.

So, I wish everybody that's heading out, including my own family a safe weekend.

But part of the reason we are a volleyball town is because of this team right here.

And the amazing work of these ladies and their coaching staff.

Uh, 3 of the players themselves, although the team is recruited from literally internationally.

3 of the players come right from our own area 2 from Louisville and 1 from right across the river. And I have to tell you it is rare to find a team of this caliber where you get that many players coming from your local area.

My family and I are season ticket holders. We watched.

Last year through your undefeated season, which was just incredible through 2 final four's. Now, through the 2nd place finished this year in the N. C. double a tournament and God only knows what the future is going to bring, but it's going to be huge.

I just wanted to say to the ladies, you are truly role models, icons and idols.

For the young athletes, and particularly young female athletes.

I mentioned to you earlier, my daughter has attended the view of all overnight camp.

And her interactions with you all have been some of the greatest impacts.

And last thing I want to say, maybe more broadly to the university level administration.

Um, many of that don't know and if you haven't been to 1 of the volleyball games, you got to go the stadium's. Awesome. It's very tight. It's very it's got a great feel to it.

But I would say to the administration is this program has grown and evolved and with all the attention it's getting nationally, let's make sure it's properly resourced.

I just hope it was a nasty rumor that I heard at 1 point about needing assistance and.

Recognizing some of the achievements that you all have made, and I will tell you the stadium is constantly sold out. So if, if it's a revenue issue, build a bigger stadium, so more of us can enjoy your matches.

Told him, I was going to report him to his corporate office for sending people to install items without ID, refusing to give their names and telling me I could not record them.

David Malay security Jeremy livers, detective and other police who have previously sent 38 sexual degradation.

That threats to me, and confessed in writing, they sent them participated in creating the death threat to Milton said to himself. See exhibit 2 that I gave you all. all

Ronald detective is also involved in the corruption LGB illegally, attached harassing to my home, which caused a fire in my home frequencies that affected my health intercept and destroy the electrical appliances and killed by 2 poodles.

When I filed against horizons with FCC, Verizon stated, they had nothing to do with it and that algea need attach the lines.

Seeds of the 3 I turned into you all I filed against with FCC and the algae, and he came and removed the lines. They have attached other illegal devices recorder, fiber optic, et cetera around.

My profit there is a corrupt circle of officials in Kentucky, and it's not just the police law, the metro police send people to murder me twice and confess to it 3 times in writing and also confess in adios. Exhibit 1.

I gave you all county Attorney's office fabricated force the facts and stated came from my neighbors in which they stated that my neighbors said, please do something about this lady. She is spitting on cars talking bad about the police. We are afraid to let our children out.

I gave all my neighbors a copy. They didn't send the fax county attorney's fax numbers at the top, which means they fax it to themselves. Gigantic office. And Russell comments. Previous U.S attorney told me they sent my information to the FBI analyst, the conversation lane and to call them for assistance because I gave package to John Yarmouth and Russell. Colin, I contacted the FBI and I take them.

They said, we told you not to call her. I take them several times saying, we told you not to call her as soon as I give my name.

So, corruption is in a lot of offices I contact the Department of criminal investigations for assistance, which is the DCI and wolf. I can't think of his 1st name.

And encourage people to utilize this building, right to come back to city hall to come back downtown. I believe there are some proposals for amendments. So I'll turn it back to the.

A president pro temp for those that I would like to make amendments. Thank you. Thank you. Councilman chambers Armstrong.

Thank you Madam President, pro temp. I had mentioned in caucus perhaps tabling because there was some outstanding legal questions. It's my understanding that.

Folks who prefer to go ahead and move that along. So I have no intention of making a motion to table and ask for folks support and going ahead and moving this role change for tonight. Thank you.

On the business day preceding the date of the meeting no notification received after 12 on the business day last preceding the date of the meeting.

Shall be effective if notification is untimely, the meeting should proceed fully in person and any member must be physically present in person to participate.

We're moving forward with was going to be ignored and I found out today that the amendment that's before you now would be proffered. I'm only after it was proffered.

So I was a little bit surprised that, you know, I was working with leadership and I thought we were moving in a direction and then I found out that I wasn't working with leadership. Instead we had this resolution before us.

So, I'm going to ask my colleagues please don't know if they choose to vote. Yes, I'm going to ask that. They please at least keep an open.

Madam President, you had 16 years and 9 and.

The eyes have it, the resolution is adopted.

I mean, the amendment has been adopted now we're back to.

Um, the actual.

Resolution is there any discussion.

Councilman Kramer, thank you, Madam President. If our colleagues would log into the system, there's a 2nd amendment there. It's the 2nd, 1 down.

This is an amendment that I had preferred the language, and I was working on the language as late as this morning.

And sent a copy of the language that is before you.

Um, to the folks with whom I had been working in order to try and find some.

Some way of recognizing the importance of what we do here. I have felt strongly and have never wavered and feeling strongly that.

Meet virtual meetings are not as effective as meeting in person. I would venture to say that that's not just a preference of man, but there's lots and lots and lots of research out there that supports the reality that.

We do not do things as well in a virtual setting as we do in person. I would also point out that.

Is a growing tourist town,

and 1 of the biggest reasons that we see and draw tourism is because of conventions conditioners businesses recognize and understand the tremendous value of being in the same place as people that

they are doing business with. And they travel a great expense touch to our delight to places like our community. I point out further.

That as folks who who are setting the example for our constituencies and setting the example for businesses and local,

we need to recognize and to understand the downtown mobile can't survive with just tourism.

If we don't get folks who work downtown back downtown, the restaurants that are supported by the tourist industry, won't be able to survive. It's a 3 legged stool. You can't you can't do it with just.

With just tourism we need, we need people in office businesses down here and so we need to be.

1st ourselves, recognizing that, that we will be more effective when we are in person and we need to recognize that we can send the message a clear and strong message.

That level is open for business and we're back at work and we need to send a message to every other company in town that.

We really believe being back in our office is back downtown back together in 1 place makes a difference.

Again, I haven't wavered in that. Anybody's listened to me. Speak knows that's where I've been all along in my efforts to try and find consensus, at least to find 14 votes that that.

Would agree that it's important. 1 of the things I've come to understand is, you know, there's.

Some of the committee work that we do, it requires quite a bit of a commitment to get down here for a committee. And for some of us that live and work in the outer parts of the community, it takes longer to get downtown.

Then the committee meeting might last, and I was subject to that myself last week it took me 25 minutes to get down here for a 20 minute meeting. And that was the only meeting I had down here that day.

So,

I recognize that that may be an issue and so the language I crafted allows for that that we could continue to meet committees could continue to meet virtually unimpeded folks felt like that was necessary for them while again.

That might not be my 1st choice. I recognize understand that that is where we are. are

Change that we made and.

Again, I thought I was operating in good faith here was recognizing understanding that there are those exceptional times when being at a council meeting is more difficult and I've been doing this for 20 years.

I can look back over the years I've been here and I can tell you, I know of instances where colleagues have folks that I would consider friends.

We're out of town with family vacations, not they're not their immediate family, but their extended family, and they had to rush back home for a council meeting because it was in the middle of a budget.

Session and then turn around the next day and drive back the same distance that they drove to get to. I get that that's a challenge while while there's a part of me that says, hey, that's part of the job, right? It's what we do.

I recognize the world has changed 1 of my 1 of my colleagues pointed out. We're in a different world, right? So, the conversation was okay.

Let's limit it to twice a year, right? We, we don't.

I wouldn't think people would travel that terribly often and, you know, people do get sick.

So the suggestion was twice a year, rather than read the entire resolution to you, it's in front of you I would strongly encourage a quick reading of it.

But the underlying sections are the ones that are most important notifications to participate.

Virtually in either a metro council meeting or committee meeting shall include a stated reason for the members virtual participation, which shall be included within the minutes of the affected meeting someone in a conversation with me today suggested that.

That it didn't feel very appropriate, that council members would have to ask permission, which I thought was interesting. That that was the comment that was made to me. Because that was precisely the comment that I had made to some others. Right?

We are all elected by 29,000 people and none of our bosses are on this council. this council

So, we don't have to ask permission.

The president of the council doesn't get to tell me what I can and can't do.

And I don't want to create a rule that gives the president.

That kind of authority so, if you read the, what what's proposed here in my language, I don't propose that the president has that authority.

What I propose instead is that council meetings would be in person. If 1 needs to attend virtually then 1 would notify the clerk.

And and to me easier, that council meeting would be able to attend virtually you don't need permission.

The only notice the, they only notice.

Excuse me, the notice that requires an explanation is in the public record. I'm not asking I'm not asking for you to tell me why you're not coming. So I can decide if it's a good enough reason or not.

The public has a right to know if you're not here.

Why are you traveling? Are you ill? Is there something going on is just a stated reason and it's not it's not when you wait for an answer, it goes in the record, right? And you can decide how you want to word that yourself.

Goes on saying metro council member participate virtually no more than 2 meetings per year. That's I think I read that. And then it allows for emergency provisions there might be in a situation or occasion where we run into another pandemic or where.

There's some kind of a natural emergency. And we may have to actually switch to virtual media in that case. So, it does allow for that. But primarily what it does is, it establishes that council meetings will be in person.

That it recognizes it understands that there might be those exceptional situations where someone may need to not be here and with a notice to the clerk.

That council member would be able to attend virtually, and they would be able to notify the clerk that they're attending. Every committee meeting virtually.

So, I'm asking for a yes. Vote. I'm happy to answer questions.

Thank you council council president Winkler.

Like that in form of motion.

The motion is before us, it has been seconded.

Is there any discussion president Winkler. Yeah, I'll just make 1 very quick comment and just to say that it, I think the previous amendment.

Already covers this, I mean, the only the material difference here is.

Putting the limit of 2 I think it's an unnecessary change. I mean, 1, if you look at the room today, the only people who aren't there, I've been traveling or sick.

Um, I, I don't think it makes any sense whether you say.

It's twice, it's 3 times and I think you look at the last meetings of last year.

1st means of this year, basically whoever can pump is there.

And are much favor people having the ability to vote because the alternative is not.

To come, the alternative is to not be there and to not vote and not represent for 30,000 people that each of us represent. So.

I would encourage everybody to to book this moment down past the ordinate says the resolution is and move on. Thank you.

Housewarming purpose Thank you. I just would like to state that I am not going to be supporting this.

I really think that, um, this amendment of whatever you call a resolution.

Thank you all too far and, um, as.

President Winkle has already spoken. I'm not there because I'm sick. I don't want to get anybody else sick.

But, as I stated earlier in the 40 years, I've been on the Council, I don't know if anyone that is abuser, they're privilege of not attending any meetings.

Um, and so I think as long as we're there in person over here, virtually, we are still here representing the needs of our constituents. So I am not supporting this.

Thank you council council and Dr Rick BLACKWELL.

Thank you, um, just a couple of things I.

Unlike councilman Kramer who mentioned earlier, that he's been very consistent with his support of the position that he takes tonight.

My position tonight will be a little different from, from where I've been in the past, because I have been a supporter of bringing folks back for the council meetings and,

and I still do believe that is the best situation.

I agree wholeheartedly that we work better as a body when we're here together when you can see each other, you can you can read body language much better.

And so, and what I've always argued is, it doesn't give you what I called the coward clause that allows you to if we're going to have a.

Room full of folks who are against the position that you're taking that that night. You suddenly go virtual. So those things are important. However, when I'm talking to council on weekly or president.

This point about what's the other option, you know, because I was thinking only in terms of folks who would choose.

Who would just simply choose not to be here as opposed to the folks that are on line tonight.

I'm certainly glad that they made the decision to be online, rather than to be here with us and just saw President sneezing fit. It looked like he had and they go so glad is there.

So I do recognize that.

I'm blessed in some ways, I don't have some of the family situations and other folks have and the family concerns that they have and I've been blessed being pretty healthy.

So, my situation maybe different from some other folks in, in, in our Council.

And so that's led to my change, because if it's a matter of sickness, or it's a matter of family obligations or whatever it might be, I think the president is exactly right. It's not a matter of that person will make the decision to come here.

If we're virtual and just, we're simply not going to have.

Council district represented on that night and so that's what's changed my mind. I wanted to explain to colleagues where I had changed my mind on my position on it.

Thank you thank you Arthur.

Sorry, I'm sorry.

Thank you Madam. Uh.

Madam president Pro, temp appreciate.

Counseling Blackwells position and.

I understand the logic makes some sense. I do want to say, I. Have been questioned about my ability.

To juggle with this job.

To represent my district, uh, and what that entails.

With my other obligations, those obligations include family.

Uh, we've all sacrificed, I think many of us here and sacrificed time with family to do this job.

That includes professional.

Sacrifices, um, there's all kinds of sacrifices that have been made here.

And that's a legitimate question. An assumption that people have, which is

This we didn't, I don't think anybody here ran because they thought it was going to be convenient.

They ran to serve and I'd say that every single 1 of you who I've talked to, you ran because you wanted to serve. So, although I appreciate.

What you're saying, counsel BLACKWELL, I would say that it's the expectation.

That we make time for this, even if that means sacrifice. And again, I think what counseling Kramer here has done is balanced that.

Which was giving the opportunity for some of the flexibility while defaulting and saying we have an appointed place of duty.

Uh, and there was an expectation, uh, particularly when you look at.

The infrastructure that our taxpayers pay for to facilitate the work that we do, it's important. We use it. So that's my position. I'll be supporting councilman Kramer's amendment. Thank you.

Councilman Owen.

So, I've been involved in some of the conversations over these rules changes as well. And I have been a proponent also of getting people back, getting all of us back in person as much as possible.

And I talked last time about the symbolism.

Involved in that there is symbolism in words in a rule.

But I guess ultimately, the best symbol we can send to the people of metro Louisville.

Is by showing up by being here that is the most important symbol that we can make.

I've gone back and forth on this. I think at the end of the day, we're all in all adults and we all are responsible to our constituents.

And I encourage all of us to show up at every opportunity that we can possibly make to be here, showing up is more than half the battle. But I think at the end of the day, I will be voting no on this.

Is there any further discussion on this amendment?

Thank you president, Tim, I'm going to support councilman Kramer in this, and I'm going to pick it back a little bit off of counseling. His statement of sacrifice.

Um, we all do this job to to serve our communities and I think it's our fiduciary responsibility.

Not just for our districts, but for our city and a whole.

If we are not downtown, and we are not serving and showing that presence. What does that say to the rest of the community? What does that to say to the rest of the city.

As well, as the rest of the businesses in our community that have gone virtual, that should be back downtown.

Thing no 1 further in the queue.

The amendment is before us.

Roll call, or this could be a resolution allowing a voice vote.

All those in favor, say, aye aye.

Opposed no, let him share with you I met him president get off the roll call. Please please.

Madame clerk opened the voting committee member Arthur.

Oh, committee member purpose.

No, Mini member chapel.

Oh, 1 moment.

Okay, um, president Winkler.

No, Madam president Pro, Tim you have 9 yes. Votes and 16 notes.

Thank you Madam clerk the amendment.

Fails now we're on to the resolution.

Is there any discussion any further discussion on the resolution that's before us?

There being none all those in favor of the resolution item number 18, please say yes.

Yes, all right how those oppose.

I think it would only be reasonable that I removed my sponsorship. Thank you. Thank you.

The next item of business is an emergency resolution added after the publishing of the final council agenda to permit this late edition, we need to vote to suspend the rules pursuant to council rule. 5.12. the council may dispense with Council rules. 6.

To allow the late acceptance of this legislation with a 2 thirds vote.

Are there any questions motion to suspend the rules?

2nd 1 are there any questions.

All those in favor, say, aye.

All right, all those opposed say, no.

The ice habits do we need a roll call vote? Madame clerk. Oh, man.

I'm good.

Madam clerk a rhythm of item, 19, the resolution and emergency resolution pursuant to the metro Council.

by Metro council constituted a violation of the local metro ethics code, red and form, have a motion and 2nd for approval. second for approval

The resolution is before us is there any discussion council member?

Councilman Anthony.

Thank you Madam President, I'll be abstaining from the vote because this is a vote related to myself.

And it would be, I think, a little obvious, hopefully, it's obvious why I'll be abstaining from that.

Uh, with that said, just as clarity and I think it is reflected in the language of the, whereas clauses.

Had provided written testimony to the ethics commission on Tuesday.

Spoken to the chairman of the ethics commission and asked for that review that meeting is this evening it's actually started at 40 PM.

So looking forward to the results from the ethics commission and moving forward with any with complying with. with

Their direction and complying with the ethics law moving forward. So thank you very much Madam President.

Thank you counsel women Thank you Madam Pro, Tim.

So, this, this was something that I thought after reading the article that was this morning, the last paragraph of the article indicated that the.

Ethics commission knew nothing of the request back. Houseman. I believe that it was because.

That request came after the question was asked of that of the president. I just want to read that the status of the commissions inquiries.

Unclear despite pigeon td's claim that he reached out to them about the situation on Tuesday commission chair. Delores loss. How do you say that.

Thank you said she did not know about any formal request related to any conflict of interest concern with. So, you know.

That that's what's going to be out there. That's what.

People are going to see and they're going to wonder what we're doing. So, I thought even though councilman has requested that formal.

Request from them that we, as a body should do that just to make sure that the viewing public knows that we.

Even, even though he has made that, and I know I've seen the emails, the general public does not know that. So, um.

Anyway, I wanted to read the resolution you all have that just section 1 and section 2,

the metro council here by request that the local metro ethics commission review the actions of council member connection with the debate on the enact of ordinance, 182 series,

2 opinions as, you know, we know that councilman has already done. So, but just the perception to the public is important that they know we're doing something.

So, anyway, I appreciate your support on this.

Councilman Kramer, thank you, Madam President. I want to.

Begin by asking to be added as the CO sponsor.

And I want to follow that immediately with.

A bit of an explanation and a request of my colleagues to join me and yes, I've, I've had an opportunity to work on the vice chair of the budget committee.

I understood full well, what was going on in the, in the different work groups. I know the and teeny and councilman. Marcus Winkler brought together brought to us.

A proposal for a project that they jointly supported. I don't know of anything and look things can be going on that.

I'm not aware of, but I don't have any reason to believe that there was anything in here that was inappropriate.

And the sooner we haven't in the ethics folks, take a look at this the sooner we can put this behind us and we can move on and Katherine can be cleared of any potential or inappropriate claims. So I'm not, I don't want.

Anybody who's listening to think that my.

Signing on as a CO sponsors, because in any way shape or form, I think the ethics commission is going to find any kind of a problem with what he did. I think the opposite is true if however something is discovered, and I'm wrong.

Then I will have to look into a camera somewhere and say, I didn't think it was any there and clearly I was mistaken. And so I'm going to ask again. My colleagues vote. Yes. And then we get this investigation underway and get it taken care of.

So we can get back to business.

The study was required to do reviewing your call 20 years post merger.

This is a part of work required or necessary. Let's put it that way as part of a.

The bipartisan commission that was created related to house by 314 passed the last session this contracts with economics professor.

Emeritus from URL, and also a professor from the University of Kentucky, the university local professor did much of the economics work from the original study 20 years ago.

So, it made sense to continue using him and then engage with a colleague from outside the local area to get as much, you know, sort of, unbiased.

Quantitative data as possible so this was amended and passed unanimously out of committee was amended because the dollar amount was reduced a little bit and there were a few items that needed to be more.

I was wondering flood, thank you, president. Pro, Tim.

The side is this side is the side of the old Jim Porter's good time. Emporium acquired the property in 2015 for an underground storage, but it was not needed and subsequently sold in 2020.

other surrounding properties were acquired in 2021 1 park, North proposed development calls. For 2, mixed use buildings, 110 stories. The other 17 stories with the maximum density of 60 units per acre. The site is proposed to have 29,000 square feet of retail.

the site is proposed to have twenty nine thousand square feet of retail

Now, and 360,000 square feet of residential. This is a companion to the property 1 park south across Lexington road, which has not been constructed as of yet. Also we need to add change a binding element, binding element number 7.

and if it's okay, I'll read that into the record so we can vote on it. Yes. vote on it yes

It's quite lengthy, but the develop, the development slash owner shall be responsible for submitting an annual report to planning and design services staff at 12 month.

Intervals from the date of the 1st certificate of occupancy for residential units until all affordable owned owner occupied units have been issued building permits and for a period of 15 years after the last affordable rental unit building permit has been

be commercially responsible.

Excuse me, she'll be a commercially reasonable form approved by planning and design services staff and generally include, but not limited to be strictly limited to the name of the development.

The number the unit numbers, the unit addresses the sell price and or rental rates of the designated affordable units. And she'll certified that the developer slash owner has made a good faith effort to verify that the tenant slash purchasers.

Purchasers were income eligible at the time of rental purchase.

Report compliance shall not require the developer owner to utilize any 3rd party accounting or certification.

The annual report shot indicate separately the number of building permit issued for the owner occupied and for rental dwellings prior to selling any affordable housing, affordable units.

The developer slash owners shall work with the planning and design services staff to develop provisions that will cover any subsequent transfers of ownerships during the affordability period, which shall be 15 years.

From the day, the certificate of occupancy for such unit, such provisions shall be negotiated. Agreed to prior to the cell of any units and I move that amendment with those changes.

So, uh, I hope you guys will indulge me a little bit on this project. I promise I will not speak.

At such links on every zoning change project that comes in front of you from district 9. but this is a very prominent location within district 9 and is a.

Unique project, I think within district 9, so I want to start off by reminding everyone that Metro counsel approved. 1 park South.

Which is a similar project of size and scope across the street.

In 2019.

Many of my constituents have clearly voice their opposition to both 1 parks, North and South both before. And after I was sworn into office.

So, I don't want anything I say, to make it sound like, I believe everyone that lives in district 9 is is in favor of this project.

With that said, I also don't want people to think that everyone in district 9, as opposed to this project, or projects of this type a mixed use more vertical construction with additional density.

Because a significant number of them have also expressed their support.

This project is without a doubt taller than we are used to seeing it is denser than we are used to seeing.

And it has more land use types, concentrated in a single mixed use development than when you're used to seeing.

And I understand those characteristics are scary because they are so different than what we're used to seeing.

But I also think if we focus on and embrace all of the potential positive impacts.

Of this project, it is also a very exciting 1.

So, I want to make it also clear that I have arrived at my, at this place, where my perspective on supporting projects of this type.

After literally decades of thinking about reading about and researching the topic.

Of neighborhood development, going back to my urban planning studies at the University of Virginia, 30 years ago.

I think of myself as a liberal as a progressive.

And that also helps inform my thinking on urban development.

It is my sincere belief that people that prioritize environment.

And housing, affordability and not separate projects that promote additional density.

From the concepts of urban sprawl, sustainable development.

Affordable housing and environmental justice. So, speaking of those things, if we say that we are not going to allow projects with additional density in our urban neighborhoods.

Then we are by default saying we want the vast majority of new development to occur in Oldham bullet and Shelby counties.

Where we are turning farmland into subdivisions when we do that, we ensure that our neighbors commutes are longer.

Our air and waterways are more polluted, and the footprint of our metro area has a much greater negative impact on the environment.

So, with that being said, building projects like this in locations where the infrastructure already exists.

The sidewalks are there, the roads are there, the sewers are there. The utilities are there.

The bus lines are there the parks are there makes more sense from an environmental standpoint.

And if we say we are supportive of these types of projects, just not in my neighborhood.

We are not walking the walk on the environment or on housing affordability. We are simply talking the talk.

So, we have a deficit, we also have a deficit of thousands of units of housing.

In this community, 75% of our land use in Jefferson County is dedicated to single family housing. And while the idea that everyone will own a single family house with a plot of land with a white picket fence fence is idealistic.

What it does as a result is put pressure.

On pricing of housing affordability across the spectrum. So it pushes housing prices up because we have too few units. It really ends up being just a simple supply demand dynamic.

And the fewer, the more deficit we have in housing units, the more it.

Pushes up prices across the spectrum. So of course, we need to focus on the affordability side of building new housing on the lowest end where people have the most acute need and are at risk of losing. Their houses are being evicted.

But every new unit that we bring on line.

Does some part in reducing that pressure pushing.

The cost of all housing higher.

As far as this particular site goes, um.

It is a unique site. I am not advocating that Lexington road be turned into Central Park West.

Although I have been accused of that this particular site.

In my opinion is a is a little bit. It's set off a little bit and its immediate neighbors are Cherokee park.

Cemetery i64.

And frankly, my neighborhood, which is not.

Right next to this location, but right up the hill Lexington.

Um, so because of that, I think this site is uniquely situated to support exactly this kind of development.

I also think these types of sites that promote additional density are good for business.

In a post covert world, as far as I'm concerned, the more people we have coming to a site like this.

Living at a site like this, the more customers we have for businesses along Lexington road and Frankfurt Avenue and that's a good thing.

It's good for public transit. A lot of times when we talk about public transit, we say it's hard to do public transit because we don't have enough density.

The more density we have in locations like this, the better our public.

Trends it works and the more efficient it is.

There isn't affordability component to this to this project. A lot of people have said, well, it's only 10% and it only lasts for 15 years and it's only 80% of the.

But what I would also say while we do need to focus on affordability.

What this does is opens up a specific number of units.

To in our neighborhood to a portion of the population that otherwise might might not be able to live there.

And so we can scoff at the numbers of the affordability component, but I don't think we should because I think it's important.

That more people get access into neighborhoods that they.

Maybe not wouldn't be able to afford otherwise there's going to be improved escape. Streetscape. There are environmental components to the project green roofs, bicycle, party, parking porous papers. Finally, I'll say.

1 of the biggest issues that people have here is they're worried about traffic.

And I won't sit here and say that I'm not at all worried about the traffic at this location.

It is a, like, the site is unique. The location is unique in the sense that to get from the highlands to Chris and Hill.

You have to go under 64 on grinstead drive.

It's a little bit of a pinch point and otherwise if you don't use that, you have to go down Lexington to paint street and around.

Or up, Lexington distills and around. So there is a traffic component to this. That does worry me some but when I weigh the potential benefits of the project.

Over and against the potential traffic congestion I fall on the positive sides of the ledger.

Far more than I do on the negative side. The ledger.

Finally, I want to remind everyone that what we're voting on today is on changing the zoning destination designation for these parcels.

We're not voting on how this project is financed.

That's a conversation that we will all be having in the very near future and we should have that conversation, but that discussion is entirely separate.

From what we're voting on here tonight, which is simply zoning.

So, I am in favor of this project, and I hope I have all of your support as well. Thanks. Thanks for.

Indulging me a little bit. Thank you. Council member.

Thank you Madam President, pro temp and I'll just say county council. I know we're going to get along swimming right here. 1st of all. I appreciate.

You reflecting both opinions of your constituents. It's, it's hard, right? And I faced tons of these decisions where you have, you know, people who are.

Some for some against, it's a hard thing to do you have to do what's right for the overall community plus what's right for your community so I appreciate the tough position you're in. But but I'll be supporting this as well. I also I want to point out.

Something related to your talk of density and height.

I've been blown away to find out that there are rules related to urban building in this city.

For example, new that you have to get waivers to go above 4 stories right? And this sort of idiocy right? This has driven us to put.

Or at least attempt to mix more urban style development. And I mean that by high density, I don't mean it by urban rural that's wrong. Density, high density into more suburban and rural areas of this community.

And I've spoken out about apartments, going on. Johnson wrote in my community, which is in the and environmentally sensitive area with no arterials on a road that is paved over farm road, right?

That makes no sense what does make sense is building up a new low. Right? What does make sense?

Is creating the volume that you're talking about and, as a matter of fact, the 1st debate I ever did, somebody asked me about affordable housing. I said, you know, you keep housing prices reasonable, you build right you build it is a supply and demand issue.

You're so right about that and I appreciate your perspective so much. This is exactly right. And to your point.

I get it scary. You write about people's perceptions on it.

And I'll absolutely join you in fighting for any infrastructure needs in the area to support it as I hope you will,

for those of us that have been dealing with development projects and our districts advocated for the East End middle school while I had

constituents buying and yelling and screaming screaming right infrastructure and I said you're right.

But we also need the middle school, right? You know, I mean, we couldn't wasn't.

Good enough to say, no to the middle school because we are screwing up the roads. We have to catch up on the roads.

We need more schools in this community. Um, so appreciate your stance. I really love it. And I do think we need to talk more about that density and the height.

That would create volume and do it in a sustainable way. Instead of what we've been doing, which is sort of splattering this stuff all over the place.

And again, I'm not saying, I don't no problem with some of the multi family that's gone to my district on Shelbyville road and major collectors, but in other places, it has been a struggle, but we need the volume. We need more buildings. So, thanks for your advocacy.

And I'm looking forward to voting for this, appreciate it.

Thank you Kelsall and flood. Thank you man approached him but I believe Sonia has this cover because we did not vote on the amendment for changes for binding number 7. so, if you will.
