## ORDINANCE NO. 033, SERIES 2023

AN ORDINANCE APPROPRIATING \$9,500 \$10,500 \$14,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 12; \$3,000 FROM DISTRICT 14; \$1,000 EACH FROM DISTRICTS 8, 10, AND 24, AND 25; AND \$500 EACH FROM DISTRICTS 9 AND 16; AND \$250 EACH FROM DISTRICTS 1, 3, 5, 15, 17, AND 21, TO METRO PARKS FOR COSTS ASSOCIATED WITH THE 10TH ANNUAL RIVERVIEW INDEPENDENCE FESTIVAL (AS AMENDED).

SPONSORED BY: COUNCIL MEMBERS BLACKWELL, FOWLER, FLOOD, OWEN, MULVIHILL, RENO-WEBER, BATSHON, REED, HAWKINS, RASHAD, PURVIS, CHAPPELL, RUHE, AND PRESIDENT WINKLER

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$9,500 \$10,500 \$14,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; \$3,000 from District 14; \$1,000 each from Districts 8, 10, and 24, and 25; and \$500 each from Districts 9 and 16; and \$250 each from Districts 1, 3, 5, 15, 17, and 21, to Metro Parks for costs associated with the 10th Annual Riverview Independence Festival.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval

or otherwise becoming law.
