Dear Denise and Council Member Purvis-

Just wanted to follow-up regarding the Boone Square restrooms. The auto lock/open feature for the restrooms in Boone Square costs us \$74/month and \$888 annually, which we will no longer be able to continue to pay as of June 30. Would you be willing to take on this expense by affording Metro Parks the funds to pay to continue this service?

We are planning to have restrooms in Chickasaw and Elliott Parks renovated by the end of FY 2021-2022. Just FYI- if wanted to have a similar feature installed at those restrooms, then the cost for the initial installation of the equipment for the service would be \$4500-\$6500 per location, then a similar annual cost for each as listed above for Boone Square.

\$54/monthly for the service, \$20 Verizon/monthly for the Wi-Fi) for the auto lock/open feature for Boone Square restroom = \$74/month ttl and \$888 annually.

That said, if Council is planning to include funding for wi-fi in the west end parks, then the \$20 monthly Verizon expense would not be needed.

LP&R is not able to lock/open all of the restrooms every day, so this service installation was prioritized in Boone Square as it is a newer bathroom, and due to some of the negative behaviors which occur there.

We are planning to have restrooms in Chickasaw and Elliott Parks renovated by the end of FY 2021-2022. The cost for the initial installation of the equipment for the service for those would be \$4500-\$6500 per location, then a similar annual cost for each as listed above for Boone Square.
