The following was discussed:

- There was a discussion regarding a homeless encampment near the Medora Elementary School.
- There was a discussion regarding the overall intent of the legislation amending the Louisville Metro Code of Ordinances with regard to homeless camps and the 21-day notice posting when in proximity to schools and day care centers.
- There was a discussion regarding changes to the ordinance focusing more on safety and risk.
- There was a discussion regarding the "right to notice" and "right to protection of items."
- There was a discussion regarding ensuring that the emergency clause and partnership component of the ordinance is preserved because it utilizes resources such as the Coalition for the Homeless to assist individuals in relocating and receiving assistance.
- There was a discussion regarding the creation of two Homeless Liaisons in the Louisville Metro Police Department to offer support to the homeless outreach coordinators.

Committee Member George proffered the following amendments to the Ordinance stating:

In the fifth "Whereas" clause stating -- "Whereas Louisville Metro Council

wishes to prioritize service provision and drive decision making around escalated action based upon risk to those individuals residing in camps and the camp's relationship to its neighbors such as schools and child care facilities."

In section 2(a) - "No department or employee of Louisville Metro Government shall displace a homeless person from a camp until Louisville Metro through the Department of Public Works and Assets has assessed the individual(s) in the camp and the camp's relationship to it neighbors using a consistent methodology to determine risk.

Strike section C(2)

Change all references to "Person first language" edits changing the phrasing from "Homeless Persons" to "People who are homeless."

- There were several questions regarding the protocol of students playing outside when a stranger is on school property.
- There was a discussion regarding the "adjacent to" language when it relates to child care centers and schools.
- There was a discussion regarding offering homeless individuals services rather than simply relocating without assistance.
- There was a discussion regarding assessing risk when an individual is on school property.
- There was a discussion regarding incorrigible homelessness.
- There was a discussion regarding efforts other than signage for notifying homeless camps.
- There was a discussion regarding prioritization of risk assessments for homeless encampments.
- There was a discussion regarding the cost and protocols for the proposed risk assessments for encampments.
- There was a discussion regarding the three phase assessment process for clearing homeless encampments that includes covering the overall health, wellness, biohazard, safety, emergency, and severity surrounding the camp.
- There was a discussion regarding the 21-Day notice when a homeless person is on Kentucky State property.
- There was a discussion regarding whether the original amendment would impact or change the clause concerning homeless individual's personal property if cleared.
- There was a discussion regarding mental health challenges and safety risks as it relates to homeless individuals.
- There were several questions regarding whether school was in session or prior to school resuming.
- There were several questions regarding how soon services were offered to the individual in question when school was back in session.
- There were several questions regarding safety concerns and risk complaints in regard to the homeless individual in question when school was back in session.

A motion was made by Vice Chair Peden, seconded by Committee Member Fox, that this Ordinance be tabled.
