AN ORDINANCE APPROPRIATING ~~\$4,100~~ \$6,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,000 FROM DISTRICT 9; \$500 EACH FROM DISTRICTS 2, 10, 12, 15, 21, AND 22, AND 24; \$400 FROM DISTRICT 13; \$300 EACH FROM DISTRICTS 1 AND 14; AND \$250 EACH FROM DISTRICTS 18 AND 23; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO ST. JOSEPH CATHOLIC ORPHAN SOCIETY FOR PUBLIC SAFETY, SANITATION, AND RENTALS FOR THE ST. JOSEPH CHILDREN'S HOME ANNUAL PICNIC FUNDRAISER (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of ~~\$4,100~~ \$6,000 is hereby appropriated from Neighborhood

Development Funds in the following manner: \$1,000 from District 9; \$500 each from Districts 2, 10, 12, 15, 21, and 22, and 24; \$400 from District 13; \$300 each from Districts 1 and 14; and \$250 each from Districts 18 and 23; through the Office of Management and Budget, to St. Joseph Catholic Orphan Society for public safety, sanitation, and rentals for the St. Joseph Children's Home Annual Picnic fundraiser.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
