WHEREAS, a Collective Bargaining Agreement has been reached between Louisville/Jefferson County Metro Government and the National Conference of Firemen & Oilers District Local 32BJ/SEIU Chapter 320.

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

SECTION I: The Collective Bargaining Agreement (effective June 23, 2022 through June 30, 2028) reached between Louisville/Jefferson County Metro Government and the National Conference of Firemen & Oilers District Local 32BJ/SEIU Chapter 320 for and on behalf of bargaining unit civilian employees within the Louisville Metro Fire Department concerning wages, other items of compensation, pension, terms of employment, benefits and other matters, be and the
