**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE “COUNCIL”) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$21,000~~ \$25,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from District 6; \$1,875 from District 15; \$1,500 each from Districts 2, 4, 7, 8, 9, 10, 12, 14, 17, 19, and 26; \$750 each from Districts 20, 22, 23, and 24; and \$375 each from Districts 13, 21, and 25; through the Office of Management and Budget, to Kentucky Shakespeare, Inc. for performances of Kentucky Shakespeare's Hamlet in parks in Louisville Metro.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
