BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$4,000 is hereby appropriated from Neighborhood Development

Funds in the following manner: \$4,000 from District 5; \$1,000 each from Districts 4 and 7; \$500 each from Districts 1, 3, 6, 8, 10, 12, and 24; and \$250 each from Districts 2, 14, 15, 17, and 21, through the Office of Management and Budget, to OneWest Corporation, for costs associated with the Winter Wonderland event at Shawnee Park.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
