## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$9,000 is hereby appropriated from District 5 Neighborhood

Development Funds, through Develop Louisville, to the Metro Housing Resource Center for the

installation of security lights to qualified homeowners.

SECTION II: The Council has determined the funds requested in this Ordinance will be

expended for a public purpose.
