AN ORDINANCE APPROPRIATING \$2,000 \$9,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,000 EACH FROM DISTRICTS 4, 21, AND 24; \$500 EACH FROM DISTRICTS 1, 2, 6, 7, 8, 9, 10, AND 13, 14, 15, 17, AND 25; AND \$250 EACH FROM DISTRICTS 3 AND 5; NEIGHBORHOOD DEVELOPMENT FUNDS, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE EXQUISITE BLACK WOMEN FOUNDATION, INC. TO SUPPORT THE 2ND ANNUAL "AN EVENING OF EXCELLENCE GALA" FUNDRAISER (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$1,000~~ \$2,000 \$9,500 is hereby appropriated from ~~District 24~~ Neighborhood Development Funds; in the following manner: \$1,000 each from Districts 4, 21, and 24; \$500 each from Districts 1, 2, 6, 7, 8, 9, 10, and 13, 14, 15, 17, and 25; and \$250 each from Districts 3 and 5; through the Office of Management and Budget, to the Exquisite Black Women Foundation, Inc. to support the 2nd annual “An Evening of Excellence Gala” Fundraiser.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
