**AN ORDINANCE APPROPRIATING \$6,500 \$9,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 EACH FROM DISTRICTS 15 AND 21; \$1,000 EACH FROM DISTRICTS 4, 12 AND 13; AND \$500 EACH FROM DISTRICTS 10, 14, 19, 22, AND 25; NEIGHBORHOOD DEVELOPMENT FUNDS, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SOUTH COMMUNITY MINISTRIES INC. TO SUPPORT THE TASTE OF LOUISVILLE FUNDRAISER (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:**

**SECTION I:** The sum of ~~\$2,000~~ \$6,500 \$9,500 is hereby appropriated from District 24 Neighborhood Development Funds; in the following manner: \$2,000 each from Districts 15 and 21;

\$1,000 each from Districts 4, 12 and 13; and \$500 each from Districts 10, 14, 19, 22, and 25; through the Office of Management and Budget, to South Community Ministries, Inc. to support the Taste of Louisville fundraiser.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
