ORDINANCE NO. _____, SERIES 202

AN ORDINANCE APPROPRIATING \$6,500 \$9,500 FROM **NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 EACH FROM** DISTRICTS 15 AND 21; \$1,000 EACH FROM DISTRICTS 4, 12 AND 13; AND \$500 EACH FROM DISTRICTS 10. 14, AND 25: **NEIGHBORHOOD** 19. 22. DEVELOPMENT FUNDS, THROUGH THE OFFICE MANAGEMENT OF AND BUDGET, TO SOUTH COMMUNITY MINISTRIES INC. TO SUPPORT THE TASTE OF LOUISVILLE FUNDRAISER (AS AMENDED).

SPONSORED BY: COUNCIL MEMBERS GEORGE, TRIPLETT, BLACKWELL, FOX, MULVIHILL, ARTHUR, FOWLER, PIAGENTINI, ENGEL, AND HOLTON STEWART

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$2,000 \$6,500 \$\$9,500 is hereby appropriated from District 21

Neighborhood Development Funds, in the following manner: \$2,000 each from Districts 15 and 21;

<u>\$1,000 each from Districts 4, 12 and 13; and \$500 each from Districts 10, 14, 19, 22, and 25;</u> through the Office of Management and Budget, to South Community Ministries, Inc. to support the Taste of Louisville fundraiser.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
