## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$17,113 is hereby appropriated from District 9 Neighborhood Development Funds, through the Office of Management and Budget, to TreesLouisville, Inc. for tree well expansions, curb repair, and tree purchases for Frankfort Avenue and the Brightsite on Grinstead Drive.
