ORDINANCE NO, SERIES 2022 AN ORDINANCE APPROPRIATING \$10,000.00 FROM DISTRICT 2 NEIGHBORHOOD DEVELOPMENT FUNDS, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO BOYS AND GIRLS CLUB, INC. FOR READING, ART, COOKING, GARDENING, TORCH, AND YOUTH OF THE MONTH CLUB							

PROGRAMS AT THE NEWBURG CLUB.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$10,000.00 is hereby appropriated from District 2 Neighborhood

Development Funds, through the Office of Management and Budget, to Boys and Girls Club, Inc. for

reading, art, cooking, gardening, torch, and Youth of the Month Club programs at the Newburg Club.

SECTION II: The Council has determined the funds requested in this Ordinance will be

expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
