BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$5,000 \$14,100 is hereby appropriated from Neighborhood

Development Funds in the following manner: \$5,000 from District 21; \$2,000 each from Districts 12, 15, and 25; \$1,000 each from Districts 3 and 14; \$600 from District 13; and \$500 from District 6; to Develop Louisville for the Southwest Dream Team to print South Points Scenic Area map cards, South Points Scenic Area signage, administrative fees for the facilitation of the Taylor/New Cut Network, and the hiring of a consultant for corridor branding of the Taylor/New Cut Network.
