FOR PROGRAMMING EXPENSES FOR TWO FUNDRAISING EVENTS (AS AMENDED).~~

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$2,500~~ ~~\$7,100~~ \$10,000 from Neighborhood Development Funds in

the following manner: \$2,500 each from Districts 14 and 25; \$1,000 from District 12; \$500 each from Districts 1, 10, and 16, 21, and 24; \$450 each from Districts 2 and 15; \$350 from District 18; and \$250 from District 13; through the Office of Management and Budget, to Shirley's Way, Inc. for programming expenses for two fundraising events. All proceeds from the two events are restricted for direct payment to cancer patients for financial needs while going through treatment.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
