SECTION I: The sum of \$5,000 \$14,500 from Neighborhood Development Funds in the following manner: \$5,000 from District 21, \$3,000 each from Districts 12, 15, and 25; and \$500 from District 10; through the Office of Management and Budget, to Iroquois Civic Club, Inc. for programming expenses associated with the Mayor's New Year's Eve Bash.
