BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$12,000 \$14,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$12,000 from District 23; and \$500 each from Districts 1, 10, 13, and 16, through the Office of Management and Budget, to Highview Arts, Inc. for costs associated with operating the Highview Arts Center.
