BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$4,000 is hereby appropriated from Neighborhood Development

Funds in the following manner: \$4,000 from District 5; <u>\$1,000 each from Districts 4 and 7</u>; <u>\$500 each from Districts 1, 3, 6, 8, 10, 12, and 24</u>; and <u>\$250 each from Districts 2, 14, 15, 17, and 21</u>, through the Office of Management and Budget, to OneWest Corporation, for costs associated with the Winter Wonderland event at Shawnee Park.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
