WHEREAS, in accordance with KRS 62.055, the County Clerk shall execute a bond for the faithful performance of the duties of that office; and

**WHEREAS**, the Legislative Council of the Louisville/Jefferson County Metro Government has determined that a \$500,000 Faithful Performance Bond is sufficient to insure the faithful performance of Barbara A. Holsclaw in her capacity as County Clerk of Jefferson County, Kentucky.

## NOW, THEREFORE, BE IT ORDERED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("COUNCIL") AS FOLLOWS:

**SECTION I:** The Council approves the aforesaid bond in the stated amount for Jefferson County Clerk Barbara A. Holsclaw and directs that the bonds shall be filed with the Jefferson County Court Clerk and the Kentucky Department of Revenue.

**SECTION II:** This Order shall take effect upon its passage and approval.
