**WHEREAS,** in accordance with KRS 70.310, the Constable shall execute a bond for the faithful performance of the duties of that office; and

**WHEREAS**, the Legislative Council of the Louisville/Jefferson County Metro Government has determined that a \$10,000 Faithful Performance Bond is sufficient to insure the faithful performance of Monica A. Flowers in her capacity as Jefferson County Constable.

## NOW, THEREFORE, BE IT ORDERED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("COUNCIL") AS FOLLOWS:

**SECTION I:** The Council approves the aforesaid bond in the stated amount for Jefferson County Constable Monica A. Flowers and directs that the bond shall be filed with the Jefferson County Court Clerk.
