AN ORDER TO APPROVE A \$10,000 PERFORMANCE BOND FOR THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT CLERK.

WHEREAS, in accordance with KRS 67.120, the clerk of the legislative council of a consolidated local government shall execute a bond to be approved by the Council;

WHEREAS, the Legislative Council of the Louisville/Jefferson County Metro Government has determined that a \$10,000 Bond is sufficient to insure the faithful performance of Sonya Harward in her capacity as Clerk of the Metro Council; and

WHEREAS, Sonya Harward was re-elected to the position of Clerk of the Metro Council on January 3, 2023 for another one year term; and

**WHEREAS**, Sonya Harward's previously executed bond is eligible for renewal every year thereafter for as long as she continues to be re-elected as Clerk of the Metro Council.
