AN ORDINANCE APPROPRIATING \$7,168 FROM DISTRICT 18 NEIGHBORHOOD FUNDS, DEVELOPMENT THROUGH THE OFFICE OF MANAGEMENT AND **HOMEOWNERS** BUDGET, TO WINDEMERE PLACE ASSOCIATION **FOR** SIDEWALK REPAIR AND MAINTENANCE.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$7,168 is hereby appropriated from District 18 Neighborhood Development Funds, through the Office of Management and Budget, to Windemere Place Homeowners Association for sidewalk repair and maintenance.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.
