BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

SECTION III: The appropriation to the Office of Management and Budget in the third round of American Rescue Plan funding [Ordinance No. 197, Series 2021] is hereby amended as set forth in Amended Schedule A, attached hereto, and is approved for Fiscal Year 2022-2023.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
