AN ORDINANCE APPROPRIATING \$9,500 \$10,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 12; \$3,000 FROM DISTRICT 14; \$1,000 <u>EACH</u> FROM DISTRICTS 10 AND 24; AND \$500 FROM DISTRICT 9, TO METRO PARKS FOR COSTS ASSOCIATED WITH THE 10TH ANNUAL RIVERVIEW INDEPENDENCE FESTIVAL (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

**SECTION I:** The sum of \$9,500 \$10,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; \$3,000 from District 14; \$1,000 each from Districts 10 and 24; and \$500 from District 9, to Metro Parks for costs associated with the 10th Annual Riverview Independence Festival.
