## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$1,000 \$2,000 \$9,500 is hereby appropriated from District 21

Neighborhood Development Funds, in the following manner: \$1,000 each from Districts 4, 21, and

24; \$500 each from Districts 1, 2, 6, 7, 8, 9, 10, and 13, 14, 15, 17, and 25; and \$250 each from

Districts 3 and 5; through the Office of Management and Budget, to the Exquisite Black Women

Foundation, Inc. to support the 2<sup>nd</sup> annual "An Evening of Excellence Gala" Fundraiser.

SECTION II: The Council has determined the funds requested in this Ordinance will be

expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and

effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
