Laramie Ct – Glenrock to dead end - \$5,000.00

Huckleberry Ct- Glenrock to dead end - \$8,000.00

Hedges Rd – Glenrock to dead end - \$15,000.00

Woodruff Ave - Conn to dead end - \$175,000.00

If any of those dead end streets off Glenrock are paved without Glenrock you would need to add 5k to the estimate due to economy of scale in lower quantities. Though, D15 has been pretty good about keeping groups like this together in the past.
