REQUESTS

- **Change in zoning** from R-4 Single Family Residential and C-N Neighborhood Commercial to OR-1 Office Residential
- **Conditional Use Permit** for a medical clinic/urgent care facility (4.2.29) (22-CUP-0103)
- **Revised Detailed District Development Plan** with Binding Elements

CASE SUMMARY/BACKGROUND

The subject site is located along Brownsboro Road between the intersections of Crossgate Lane and Warrington Way, and consists of one undeveloped parcel. The site is partially R-4 and partially C-N. The applicant proposes to rezone the site to OR-1 to construct two new office buildings.

The neighborhood of the site is generally mixed-use, with single-family development located to the south-east and north-east, and commercial development located to the north-west and south-west. The site is located in the Neighborhood form but is adjacent to Town Center form. US Highway 42 is located nearby to the north-west. The intersection with I-264 is located nearby to the south-west.

The site was partially rezoned from R-4 to C-N under docket 17ZONE1025. That zoning change included a Conditional Use Permit for a senior living facility on the portion that remained R-4, and a variance for the structures to exceed the maximum allowed setback along Brownsboro Road. The variance runs with the land and continues to apply to the current site plan.

STAFF FINDING

Staff finds that the proposed zoning change meets the guidelines of the Comprehensive Plan. The site plan meets the requirements of the Land Development Code and generally meets the guidelines of the Comprehensive Plan. The Planning Commission must determine if the Conditional Use Permit meets the requirements of the Land Development Code.

TECHNICAL REVIEW

Plan 2040

Land Development Code (Louisville Metro)

MSD and Transportation Planning have provided preliminary approval of the proposal.

INTERESTED PARTY COMMENTS

No interested party comments have been received by staff.

STANDARD OF REVIEW FOR REZONING

Criteria for granting the proposed form district change/rezoning: KRS Chapter 100.213

1. The proposed form district/rezoning change complies with the applicable guidelines and policies Plan 2040; OR
2. The existing form district/zoning classification is inappropriate and the proposed classification is appropriate; OR
3. There have been major changes of an economic, physical, or social nature within the area involved which were not anticipated in Plan 2040 which have substantially altered the basic character of the area.

STAFF ANALYSIS FOR CHANGE IN ZONING

The site is located in the Neighborhood Form District

The Neighborhood Form is characterized by predominantly residential uses that vary from low to high density and that blend compatibly into the existing landscape and neighborhood areas. High-density uses will be limited in scope to minor or major arterials and to areas that have limited impact on the low to moderate density residential areas.

The Neighborhood Form will contain diverse housing types in order to provide housing choice for differing ages, incomes and abilities. New neighborhoods are encouraged to incorporate these different housing types within a neighborhood as long as the different types are designed to be compatible with nearby land uses. These types may include, but not be limited to, large lot single family developments with cul-de-sacs, traditional neighborhoods with short blocks or walkways in the middle of long blocks to connect with other streets, villages and zero-lot line neighborhoods with open space, and high density multi-family housing.

The Neighborhood Form may contain open space and, at appropriate locations, civic uses and neighborhood centers with a mixture of uses such as offices, retail shops, restaurants and services. These neighborhood centers should be at a scale that is appropriate for nearby neighborhoods. The Neighborhood Form should provide for accessibility and connectivity between adjacent uses and neighborhoods by automobile, pedestrian, bicycle and transit.

Neighborhood streets may be either curvilinear, rectilinear or in a grid pattern and should be designed to support physical activity for all users and invite human interaction. Streets are connected and easily accessible to each other, using design elements such as short blocks or bike/walkways in the middle of long blocks to connect with other streets. Examples of design elements that encourage this interaction include narrow street widths, street trees, sidewalks, shaded seating/gathering areas and bus stops. Placement of utilities should permit the planting of shade trees along both sides of the streets.

Following is staff's analysis of the proposed rezoning against the Goals, Objectives and Policies of Plan 2040.

The proposed zoning district would permit low-intensity office uses which are generally compatible with nearby residences. Access to the site is via Brownsboro Road, a minor arterial at this location. The neighborhood is generally mixed-use, with residential and office uses to the south of Brownsboro Road

and commercial uses to the north. The applicant will improve the transit stop adjacent to the site, which will benefit users of transit who need to visit or work at the site.

The applicant also proposes a Conditional Use Permit in order to utilize a portion of one of the buildings for an urgent care facility. The urgent care facility will be a neighborhood-serving use, providing urgent medical care as needed in the neighborhood.

The proposed zoning district is generally in compliance with the plan elements and CHASE principles of Plan 2040. All other agency comments should be addressed to demonstrate compliance with the remaining Goals, Objectives and Policies of Plan 2040.

A checklist is attached to the end of this staff report with a more detailed analysis. The Louisville Metro Planning Commission is charged with making a recommendation to the Louisville Metro Council regarding the appropriateness of this zoning map amendment. The Louisville Metro Council has zoning authority over the property in question.

STANDARD OF REVIEW AND STAFF ANALYSIS FOR CONDITIONAL USE PERMIT

1. Is the proposal consistent with the applicable policies of the Comprehensive Plan?

STAFF: The Comprehensive Plan describes the Neighborhood form as containing diverse housing types to provide housing choice for differing ages, incomes and abilities. The proposal complies with this description. The site is located across Brownsboro Road from a Town Center form district with commercial uses. Community Form Goal 2 is to encourage sustainable growth and density around mixed-use centers and corridors. The proposal complies with policies under this goal.

2. Is the proposal compatible with surrounding land uses and the general character of the area including such factors as height, bulk, scale, intensity, traffic, noise, odor, drainage, dust, lighting, appearance, etc?

STAFF: The proposal is compatible with surrounding uses and provides appropriate transitions between uses that are substantially different in scale and intensity or density of development such as landscaped buffer yards, vegetative berms, compatible building design and materials, height restrictions, or setback requirements. The proposal provides a transition between residential uses and non-residential uses.

3. Are necessary public facilities (both on-site and off-site), such as transportation, sanitation, water, sewer, drainage, emergency services, education, recreation, etc. adequate to serve the proposed use?

STAFF: Necessary public facilities are available or being provided by the proposal as demonstrated on the detailed district development plan.

4. Does the proposal comply with the following specific standards required to obtain the conditional use permit requested?

Hospitals and medical clinics may be allowed in any district upon the granting of a Conditional Use Permit and compliance with the listed requirements:

- A. In form districts where nonresidential freestanding signs are not permitted, a single freestanding on-premise sign, not exceeding 80 square feet in area and not exceeding 10

feet in height, may be placed at each major entrance. Attached signs shall be designed in accordance with form district requirements, but the Board reserves the right to approve the size and location of all attached signs.

STAFF: The applicant must comply with this requirement.

B. All buildings and structures shall be at least 30 feet from any property line.

STAFF: The site plan complies with this requirement.

C. Medical clinics shall provide an indoor waiting area(s) for clients. The waiting area shall be large enough to accommodate the clients arriving for services.

STAFF: The applicant must comply with this requirement.

D. Parking for medical clinics shall be adequate to accommodate the maximum number of clients expected to be at the site at one time.

STAFF: The Planning Commission must determine if parking is adequate for the office uses as well as the proposed urgent care use.

E. Such facilities shall be located on or near a collector or arterial street with reasonable access to public transportation.

STAFF: Brownsboro Road is a minor arterial at this location and a transit stop is located in the right-of-way adjacent to the site.

STANDARD OF REVIEW AND STAFF ANALYSIS FOR DDDP

- (a) The conservation of natural resources on the property proposed for development, including: trees and other living vegetation, steep slopes, water courses, flood plains, soils, air quality, scenic views, and historic sites;

STAFF: No natural resources are evident on the site. The mature trees located on the site are mainly in decline and will need to be removed relatively soon regardless of the development of the site.

- (b) The provisions for safe and efficient vehicular and pedestrian transportation both within the development and the community;

STAFF: Provisions for safe and efficient vehicular and pedestrian transportation within and around the development and the community has been provided, and Metro Public Works has approved the preliminary development plan.

- (c) The provision of sufficient open space (scenic and recreational) to meet the needs of the proposed development;

STAFF: No open space provisions are pertinent to the request.

- (d) The provision of adequate drainage facilities on the subject site in order to prevent drainage problems from occurring on the subject site or within the community;

STAFF: The Metropolitan Sewer District has approved the preliminary development plan and will ensure the provision of adequate drainage facilities on the subject site in order to prevent drainage problems from occurring on the subject site or within the community.

- (e) The compatibility of the overall site design (location of buildings, parking lots, screening, landscaping) and land use or uses with the existing and projected future development of the area;

STAFF: The overall site design is in compliance with existing and planned future development in the area. The proposal is for two two-story office buildings, which will have a relatively low profile in comparison with the residential uses located nearby.

- (f) Conformance of the development plan with the Comprehensive Plan and Land Development Code. Revised plan certain development plans shall be evaluated for conformance with the non-residential and mixed-use intent of the form districts and comprehensive plan.

STAFF: The development plan conforms to applicable requirements of the Land Development Code. The site plan generally complies with the policies and guidelines of the Comprehensive Plan.

REQUIRED ACTIONS

- **RECOMMEND** that Metro Council **APPROVE** or **DENY** the **Change-in-Zoning** from R4 and C-N to OR-1
- **APPROVE** or **DENY** the **Conditional Use Permit**
- **APPROVE** or **DENY** the **Revised Detailed District Development Plan with Binding Elements**

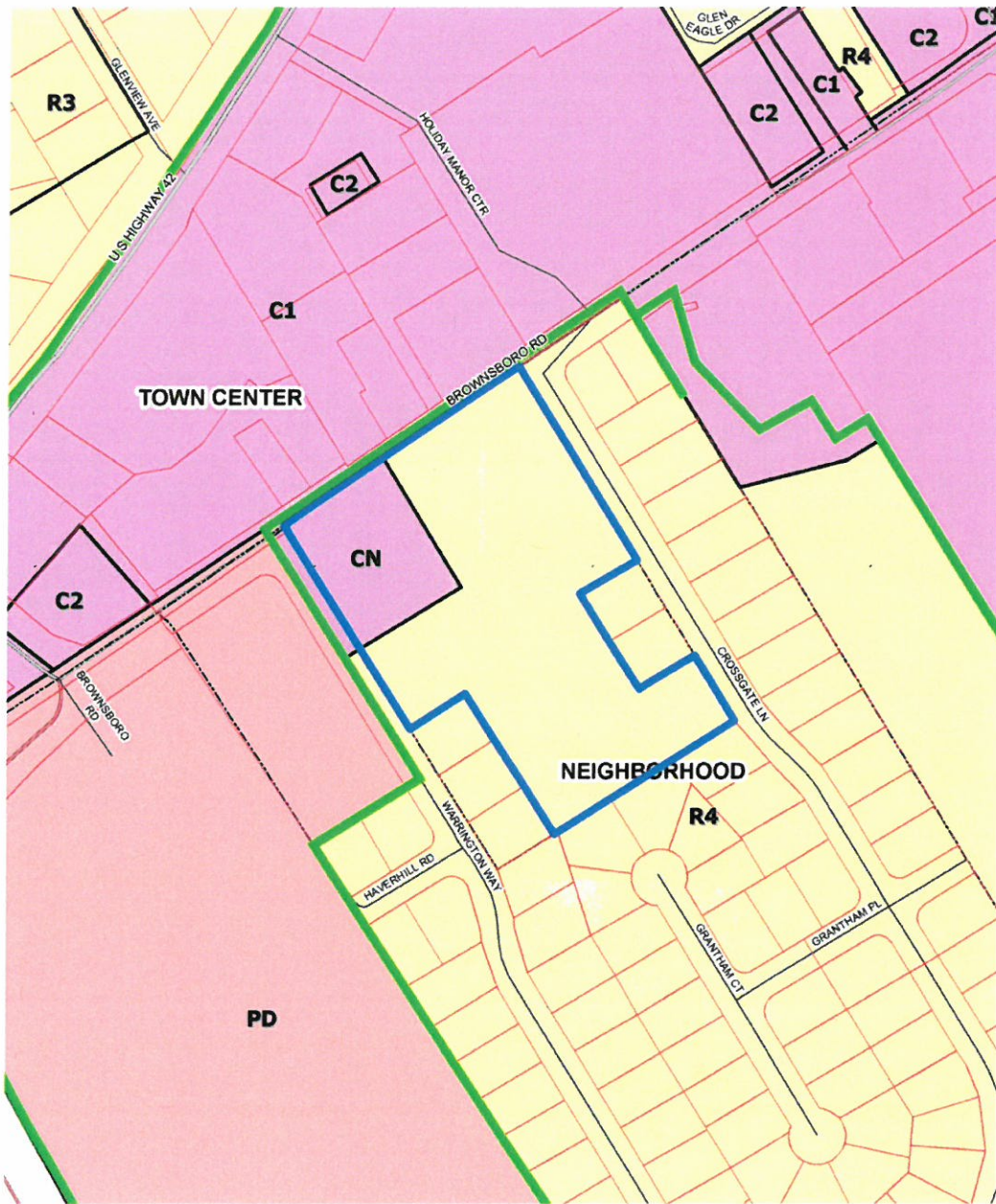

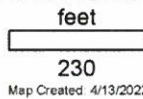

CASE SUMMARY/BACKGROUND

The applicant proposes to rezone the R-4 portion of the site to C-N to construct two new office buildings.

The neighborhood of the site is generally mixed-use, with single-family development located to the south-east and north-east, and commercial development located to the north-west and south-west. The site is located in the Neighborhood form but is adjacent to Town Center form. US Highway 42 is located nearby to the north-west. The intersection with I-264 is located nearby to the south-west.

The site was partially rezoned from R-4 to C-N under docket 17ZONE1025. That zoning change included a Conditional Use Permit for a senior living facility on the portion that remained R-4, and a variance for the structures to exceed the maximum allowed setback along Brownsboro Road. The variance runs with the land and continues to apply to the current site plan.

These neighborhood centers should be at a scale that is appropriate for nearby neighborhoods. The Neighborhood Form should provide for accessibility and connectivity between adjacent uses and neighborhoods by automobile, pedestrian, bicycle and transit.

Neighborhood streets may be either curvilinear, rectilinear or in a grid pattern and should be designed to support physical activity for all users and invite human interaction. Streets are connected and easily accessible to each other, using design elements such as short blocks or bike/walkways in the middle of long blocks to connect with other streets. Examples of design elements that encourage this interaction include narrow street widths, street trees, sidewalks, shaded seating/gathering areas and bus stops. Placement of utilities should permit the planting of shade trees along both sides of the streets.

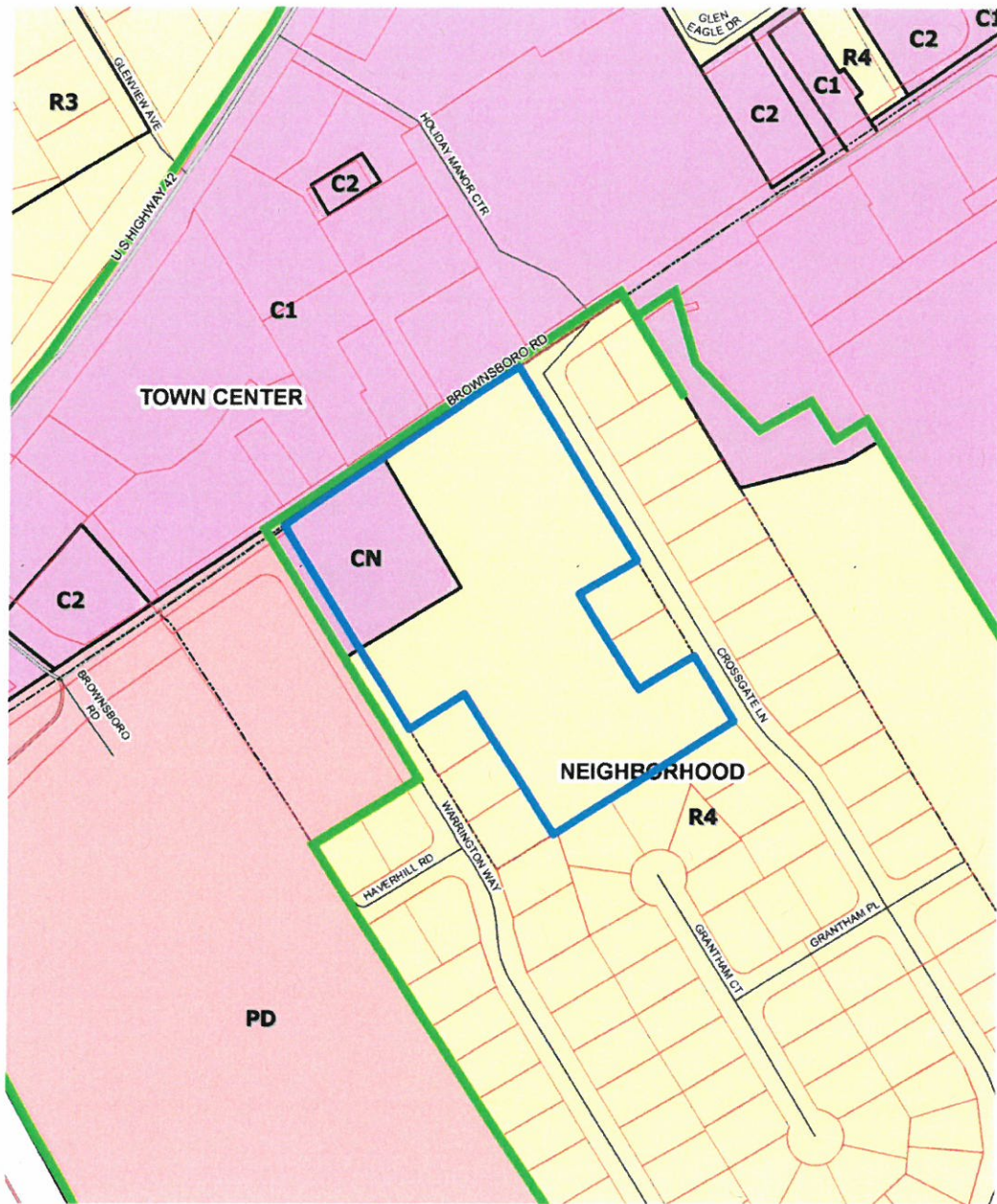

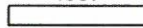

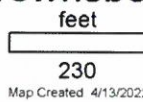

The proposed zoning district would not permit noxious odors, particulates or emissions. Access to the site is via Brownsboro Road, a minor arterial at this location. The proposed zoning district would not permit uses generating high levels of noise. The proposed zoning district would not

permit uses handling hazardous or flammable materials, or uses similar to junkyards, landfills or quarries.
