We aren't interested in scanning on Smyrna it's going into the neighborhoods.

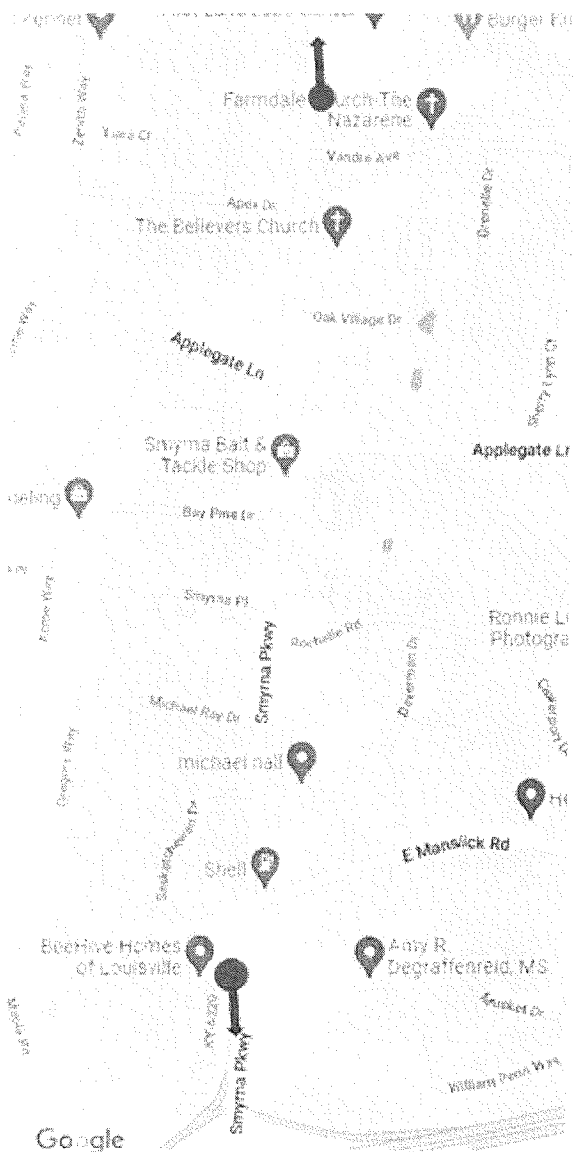

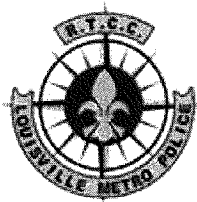
