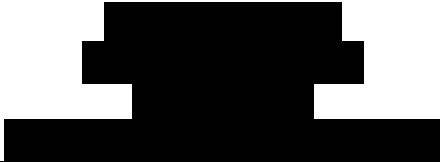

- Rolled out numerous new safety programs including a safety text message system, first responder team, spill response team, and hot work program

- Worked closely with all departments to continually push our overall plant safety forward
- Introduced a safety dojo kaizen and overhaul the new-hire training. We saw over 200 days without an OSHA recordable as a result of this
- Introduced early symptom intervention to our site through a partnership with KORT Physical Therapy
- Removed multiple layers of PPE in various areas through engineering controls
- Analyzed, audited, and followed up on confined space permits, lockout sheets, equipment checksheets, and training paperwork
