RE: 8th Division Request for Funding for (2) Radar Speed Trailers

LMPD 8th Division is respectfully requesting the funding for 2 additional radar speed trailers for the following reasons:

The division only has 4 machines to cover almost 90 square miles.

In January, 7 requests for a speed trailer were received. During this time only 3 machines were available because the 4th one was at the shop being serviced.

It is preferred to have the machine at the location for a minimum of one week to be effective and to be able to acquire accurate statistical data. This creates a waiting list for several weeks to a month depending on the number of requests.

In addition to the requests for speed machines for the division, there were numerous speeding complaints.

The division only has 2 traffic officers, and they are responsible for taking the division traffic accidents, handling the traffic complaints, and conducting traffic enforcement on the expressways.

With this amount of work for 2 officers, traffic complaints sometimes must wait longer than we would like. During the time of high volumes of requests/accidents, speed machines can be utilized to slow traffic down until the officers are available to do traffic enforcement. This can reduce traffic accidents and fatalities.

There are a couple of schools in the division that do not have traffic guards. Numerous requests for assistance with speeding are received each school year for these locations. Speed trailers can be utilized to slow vehicles down in these

areas. Unfortunately, the use of 2 speed machines are usually required for each direction of travel due to having 4 traffic lanes and 1 turning lane. This leaves only 2 machines for the remainder of the division's requests.

It is important to note that most of the divisions speed trailer requests and traffic complaints are from Metro Council Members.

The attachment contains an estimate for (2) radar speed trailers that was received on 10/31/2022. If this funding is approved LMPD will need to get another quote to ensure the proper amount is obtained.
