They've got a coalition for the homeless as well as obtaining the veterans, uh, off of the street, too. And I think that they could call it containment 0 that they have gotten from the veterans. So that's a very plus for the homeless coalition. And I ask for your support.

Thank you just real quick. Everyone got an email copy and if you're here in the room, you got a hard copy of.

Basically, some suggestions from.

And, I mean, some of them are all right.

Some of them might take issue with such as the hiring of.

Council specific design person, and why I bring that up is, is we gave them money last fiscal year and now we've given the money this fiscal year to hire more design people and they haven't hired anybody.

They claim they can't get anybody to apply, which is fine. But then again, part of the suggestion is.

To create another spot that's funded specifically by.

Counsel money, and again, we can't hire anybody. Now. I'm not sure what to do with that information.

There was some discussion today as we were kind of talking through it. Where they would start giving us 2 estimates 1 to do the design.

In house, which would be cheaper or a 2nd, and then a 2nd, 1.

To do the design using a contract designer, which would cost and I'm going to make up a figure 10,000 dollars more.

And but it would be faster and, I mean, part of my discussion today was, if you had any project I've ever had if you told me, it was only 10,000

dollars more but it would get done within 6 months to a year of the same appropriation. I would have taken that in a heartbeat.

Um, so I don't think that's the answer they wanted, but it was still

thrown out there.

So, I just want to I brought it up, so we can have a brief moment if anybody actually read the document and wanted to comment on it, if not, I'm encouraging you to read the document tweak it change it.

At some point, I'm really, I guess, for a long the end game that some of you may be wondering, I'm not really.

Wanting to pull this. I'd like to modify it and make some official changes.

And again, I'm not out of here until the end of the year. So if we want to tinker with it for another few months, I'm okay with that. But something needs to desperately be done, going forward on these projects, whether it's public works, whether it's parks, whether it's anything else. So they don't last.

For years, and again, I'm not saying I have the best solution. And I'm not saying this document that was given to us today is the best solution.

But we're going to have to start coming up with something and so any ideas, any 1 liners you want to add in whatever it is email me text me, do whatever and we'll start trying to craft something. That becomes the final version,

so we have so currently, um, according to this, we have 8 project managers.

And they are suggesting that we do 2 more for Council projects.

## Committee Member Peden

Um, so the figure I have is we have 8.

Approved spots we only have 5 project managers. Oh, gotcha.

And that's part of it now, if that's if that paper indicates differently, I was told verbally today. We have 5.

So, and that, well, within parks.

So, you may be reading a different line than I am.

Oh, yeah, yeah, there it is. Parks and recreation, engineering and planning division as a total of 5 project managers. That's in the very last paragraph of page. 1.

# Chair Blackwell

Okay, public works may have more or less et cetera. Yeah, that's what it was. It was the paragraph above it. Okay. The public works is managing let's say so, are they talking about doing 2?
Um, doing 1 for.

Um, 1 for.

# Committee Member Peden

Well, the way I read it, I just want 1 for like, all of our projects. Like, we have a dedicated project manager, whether it's. Parks whether it's public works, whether it's whatever it's ours. And I'm not necessarily sure if we did anything, it would be re, route 1 of the ones that are already there.

But I'm still going back to the comment I made earlier they have unfilled vacancies now.

From where they said 2 years ago, 2, fiscal years ago, we need more designer more project and the money.

Then we, even the following year, they couldn't fill that spot. We gave them more money.

To fill, like, pay them more still couldn't attract them.

And so that's kind of where we are, we have unfilled vacancies now. Why add another unfilled vacancy.

Or 2, the suggestion is to hire 2 project managers, all kinds of projects, and doing some research. Some other cities actually have what's called the DoD Department of design.

Where parks public works, and I guess any other agency, they all share the engineers. It's a group of people who sit around and.

You know, talk about auto CAD all day long, but that's their job. They get a.

You know, they every department, they're not a public works engineer. They're not a parks engineer. They're not a, you know, waste management engineer.

They're just an engineer for the city and they do whatever project comes across their desk.

And I'm not, I guess, in brief.

The brief Googling I did of that. It sounds plausible, but it would take a complete overhaul of everything we know in this city.

So, I'm not sure it's a plausible solution, but it is 1 that's out there, floating around in other locations.

Take take a note, take a seat for the next problem. Yes, I gotcha. I didn't call anybody to find out. How do you know what happens if you, you know, our 1Million dollar road project get caught behind a 10,000 dollar playground project? I'm not sure how that rolls.

#### Chair Blackwell

Right so. Good point. That would yeah, we'd need to look at that further. I'm sure.

Do we have any other? Um, I don't see anyone else in the queue anyone have any questions or? Yes, there's a Councilman Fox?

## Committee Member Fox

Yes, sir. Thank you. Mr. chair. Just 1 observation about getting in line. Keep in mind under the, uh.

Current system I have 1 that's been in line through 2 administrations for a total of almost.

5+years so get in line.

Draw on your little ticket, as you walk in, maybe more effective.

#### Chair Blackwell

It might be preferable.

Yeah, I mean, the current system, like I say, we're over 5 years for sidewalk project.
