I WANT TO SPEAK EVER SO BRIEFLY ABOUT A CAUSE THAT THOSE OF US WHO CROSSED THE AGE OF 50 AND I'LL CLAIM TO BE CLOSER TO THAT THAN I ACTUALLY AM AND CONCERN FOR PROSTATE CANCER.

WHAT CAN BE DONE TO PREVENT THAT.

I CAN SAY IN THE LAST SEVERAL MONTHS HAS TAKEN IT UPON HIMSELF TO DO WHAT HE COULD TO ELEVATE AWARENESS IN THE COMMUNITY OF THE EFFECTS OF PROSTATE CANCER AND IF YOU GET A TEST IT AND YOU CATCH IT EARLY, IT IS A TREATABLE CANCER AND NOT SOMETHING TO BE AS AFRAID OF AS WE ALL ARE WHEN WE HEAR THE WORD CANCER. I'LL BE THERE TO SUPPORT SCOTT AND ALL HE'S DONE. HE REACHED OUT, I BELIEVE THE DOCTOR THAT DID THE SURGERY IS -- IS -- AS I UNDERSTAND IT, HE'S LOOKING AT HIS CALENDAR TO BE AVAILABLE. I DON'T WANT TO FIND OUT.

WE ASK METRO COUNCIL TO CONTINUE TO OPPOSE A CRO IN ALL ASPECTS, AS WELL AS FOR DIVERSITY AND WAYS TO LIVE IN JEFFERSON COUNTY. HEALTHY RECREATION AND BETTER PROTECT WATER QUALITY AND TRIBUTARIES.

THAT'S THE DRO.

IT IS A VISIONARY ACHIEVEMENT THAT HAS BEEN ON THE BOOKS UNCHANGED FOR NEARLY 30 YEARS AND IS MORE RELEVANT TODAY AS THE METRO CONTINUES TO MOVE FROM -- FROM THE EAST AND SOUTH. THIS WAS 30 YEARS AGO.

WITH THE HELP OF THE DNA DISTRICT COMMISSIONER, CAME FOR CANOE RENTALS, IT WAS HIS IDEA, WE VOLUNTEERED AND SERVED FOOD AND DRINKS AND REMOVED TWO KINDS OF TAR AND APPLIANCES AND WATER HEATERS AND MORE ON OUR FIRST CREEK CLEAN-UP. SINCE 1991 ALONG WITH THE HELP OF THE COMMISSIONERS FROM THE -- FROM THE A DISTRICT AND IN LATER YEARS WORKING WITH METRO COUNCIL, DISTRICTS 20, 22, 19.

THEY HAVE REMOVED 50 TONS OF APPLIANCES, GAS TANKS.

SHINGLES, SIDING, MANY MORE THINGS.

THE PANDEMIC HAS HALTED ANY CREEK SWEEP FOR 2020 IT AND 2021. THE CREEK IS FULL OF PLASTIC.

BEFORE WE DEBATE THIS RESOLUTION I WOULD LIKE TO LAY OUT FREQUENTLY ASKED QUESTIONS WITH THE FACTS.

FIVE QUESTIONS.

WHAT ARE REPARATIONS?

TWO, INSPIRED BY PIAGENTINI AND COMMITTEE, WHY REPARATION? THREE, WHEN HAVE WE PAID REPARATIONS BEFORE?

FOUR, WHERE DO THEY COME FROM?

FIVE HOW DO WE DECIDE WHO GETS THEM?

THE REPARATIONS IS DESCRIBED FOR HARM SUFFERED AS COMPENSATION THAT SHOULD BE PROVIDED FOR ANY ECONOMICALLY ASSESSABLE DAMAGE AND PROPORTIONATE TO THE CASES RESULTING INTERNATIONAL HUMAN RIGHTS LAW AND SERIOUS VIOLATIONS OF INTERNATIONAL HUMANITARIAN LAW.

SUCH AS, A, PHYSICAL OR MENTAL HARM.

B, LOST OPPORTUNITIES, INCLUDING EMPLOYMENT, EDUCATION, AND SOCIAL BENEFITS.

C, MATERIAL DAMAGES AND LOSS OF EARNINGS INCLUDING LOSS OF EARNING POTENTIAL.

MORAL DAMAGE AND COST FOR LEGAL AND MEDICINE AND MEDICAL SERVICES AND PSYCHOLOGICAL AND SOCIAL SERVICES.

WHY REPARATION?

AND IN REGARDS TO A, PHYSICAL OR MENTAL HARM, MILLIONS OF SLAVES PERISHED ON SHIPS.

MANY WERE SHACKLED TOGETHER AND PACKED TOGETHER SO TIGHTLY THEY COULD NOT SIT UP.

FORCED TO BE ABOUT POISONOUS HEAT AND LAY FOR HOURS IN THEIR OWN DEFECATION AND BLOOD AND MUCUS COVERING THE FLOOR AND OF COURSE FACING ILLNESSES. SOME DECIDED TO STARVE THEMSELVES TO DEATH OR JUMP AND DIE BY SUICIDE.

THIS WAS COMMON ON THE TRIP ACROSS THE ATLANTIC.

FOR ANYONE SHALL WE SAY, WAS LUCKY TO REACH AMERICAN SOIL, EXPERIENCED AN AMERICAN SLAVERY DESCRIBED AS BRUTAL AND BARBARIC.

THERE WAS AN INCENTIVE TO RAPE THE SLAVES.

BLACK DEFENDANTS WERE EXECUTED FOR RELATIVELY PETTY CRIMES. VIRGINIA AND THE 1830S, THERE WAS FIVE CAPITAL CLIMBS FOR WHITES AND 72 CAPITAL OFFENSES FOR BLACK.

A VALUE OF SLAVE, SOME STATES HAD TO PAY DAMAGES TO OWNERS WHOSE SLAVES WERE EXECUTED FOR COMMITTING SO-CALLED CAPITAL EXPENSES. GUESS WHO WAS NEVER PAID?

2 1/2 CENTURIES OF FREE LABOR, SLAVES OR THEIR DESCENDANTS. REGARD TO B.

LOST OPPORTUNITIES INCLUDING EMPLOYMENT, EDUCATION AND SOCIAL BENEFIT.

EVEN AFTER SLAVERY WAS ABOLISHED, WHITE COMMUNITIES KILLED BLACK PEOPLE WITH IMPUNITY WITH ORGANIZES SUCH AS KKK AND BEYOND. IN THE FIRST YEARS AFTER EMANCIPATION, THE BLACK PEOPLE WHO BRAVELY SEIZED NEW OPPORTUNITIES TO PURSUE EDUCATION RISKED THEIR OWN LIVES.

RACIAL VIOLENCE KILLED MANY AND TERRORIZED MANY MORE. THEY KNEW AFTER A LONG START, HARD WON FREEDOM, NOW THEY WERE PLACED IN SOME DANGER.

ACROSS THE UNITED STATES WHITE MOBS WAGED BLOODY MASSACRES TO PREVENT BLACK COMMUNITIES FROM EXERCISING THEIR VOTING RIGHTS. BLACK EDUCATION WAS THE TARGET OF VIOLENCE AS EXCITE COMMUNITIES CLUNG TO THE IDEAS OF BLACKS BEING A BOTTOM CAST AND START TO TRACK BLACK PEOPLE.

1870 WHITE MOBS ATTACKED EVERY SCHOOLHOUSE.

AND THEN OUTRAGED AT THE LOCAL BLACK SCHOOL LYNCHED FOUR BLACK MEN.

A WHITE MOB TERRORIZED EVERYONE IN SIGHT WHO HAD SKIN LIKE MINE BECAUSE OF AN ALLEGED RAPE.

THAT TOWN WENT FROM A THOUSAND BLACK PEOPLE TO ZERO WITHIN EIGHT YEARS BECAUSE OF THIS TERRORISM.

EVENTUALLY THE PERPETUATORS FLOODED THE AREA AND COVERING UP AN ENTIRE BLACK TOWN, MAKING A LAKE KNOWN TODAY AS LAKE LINEER. I'M SURE YOU HEARD OF TULSA OKLAHOMA WHERE WHITE MOBS FLEW OTHER BOMBING LITTLE BLACK BOYS, AND THEIR FAMILIES.

LET'S TALK ABOUT KENTUCKY, ONE OF THE LARGEST BLACK POPULATION, 20 PERCENT IN THE 1860S BUT BECAUSE OF LYNCHING AND BURNING AND SHOOTING AND TERRORISM FROM OUR VERY OWN FELLOW KENTUCKIANS THAT BLACK POPULATION WENT FROM 20 PERCENT TO LESS THAN 7 PERCENT IN THE 1950S AND TODAY IT IS ONLY 8 PERCENT.

WE HAD HALF A MILLION ACRES OF LAND FOLLOWING THE CIVIL WAR BECAUSE OF PROMISES MADE THAT WERE STOLEN AND GIVEN TO CONFEDERATES AND ENSLAVED US AND ENTERED INTO CONTRACTS, A NEW FORM OF SLIVERY.

THE BACKLASH WASN'T ENOUGH, THERE WAS A NOW PHENOMENA, KNOWN AS MINSTREL SHOWS AND THE POPULAR CHARACTER NAMED JIM CROW WHO IS ACTUALLY AN ELDERLY DISABLED BLACK MAN IN LOUISVILLE, KENTUCKY, A MAN NAMED THOMAS, A WHITE MAN OBSERVED.

HE SANG AND PAINTED HIS FACE BLACK.

HE MADE FUN OF YOUR BLACK LOUISVILIAN.

THAT SAME NAME, JIM CROW BECAME THE NAME OF THE GAME IN THE SOUTH.

THOSE LAWS PREVENTED US FROM HAVING THE SAME SCHOOLS,

TRANSPORTATION, NEIGHBORHOODS, WORKPLACES, VOTING ACCESS WELL INTO THE 1960S.

THESE WERE SEPARATE AND UNEQUAL AS WHITES HAD EVERYTHING THEY NEEDED TO THRIVE AND BLACKS HAD NOTHING.

THE BLACK AMERICANS DISCRIMINATED AGAINST WERE NEVER PAID. MATERIAL DAMAGES AND LOSS OF EARNINGS, INCLUDING LOSS OF POTENTIAL EARNINGS.

AND PROFESSOR THOMAS KRAMER, PROFESSOR OF PUBLIC POLICY AT THE UNIVERSITY OF CONNECTICUT HAS ESTIMATED THE SLAVE POPULATION MULTIPLIED WOULD BE 1920 BILLION TODAY.

THIS DEBT HAS NEVER BEEN PAID.

LET'S TALK ABOUT WHAT REPARATIONS HAVE BEEN PAID. EMANCIPATION ACT OF 1962 PROVIDED 300 DOLLARS PER EMANCIPATED SLAVE TO THE OWNERS.

THE LAND ACT OF 1924, SETTLED LAND TITLE DISPUTES AND APPOINTMENTS OF 1.3 MILLION FOR THE LAND THEY LOST. THE 1927 IS SHOSHONIES.

ACQUISITION OF LAND FOR NATIVES.

TREATY CLAIMS TO THE UNITED STATES GOVERNMENT. THEY AWARDED MORE THAN 818 MILLION IN JUDGMENTS. THE NAVAHO HOPI RESOLUTION ACT WAS PASSED AUTHORIZING AN APPROPRIATION OF 88.5 MILLION OVER TEN YEARS FOR A PROGRAM BENEFITING THOSE GROUPS INCLUDING A SOIL CONSERVATIONIST. AND INDUSTRY AND DEVELOPMENT ON A RESERVATION AND ASSISTANCE FOR FINDING EMPLOYMENT OFF THE RESOLUTION.

THE CLAIMS SETTLEMENT ACT OF 1971 PROVIDED ONE BILLION DOLLARS AND 44 MILLION ACRES OF LAND TO ALASKAN NATIVES FOR LONG RESOLVED ISSUES.

THE CIVIL LIBERTIES OUT OF 1988 PROVIDED 1.2 BILLION TO JAPANESE AMERICANS AND 5.2 IT TO UGANDIANS.

AND A LAND TRUST FOR THEIR COMMUNITIES.

THE U.S. DEPARTMENT OF STATE AGREED TO OVERSEE AND CONTRIBUTE 60 MILLION DOLLARS FROM THE FRENCH NATIONAL ASSEMBLY TO PROVIDE REPARATIONS FOR HOLOCAUST SURVIVORS WHO SUFFERED AN ATROCITY. NOWHERE NEAR HERE.

AND WERE ALSO ALLOCATING 12 MILLION DOLLARS OF OUR OWN MONEY FOR FURTHER DIRECT ASSISTANCE. THESE ARE SEVERAL EXAMPLES OF DOZENS OVER THE COURSE OF THE UNITED STATES GOVERNMENT PAYING REPARATIONS.

WHERE DOES IT COME FROM?

FROM THE EXAMPLES I GAVE YOU.

YOU MAY HAVE A FEAR ABOUT THE ESTIMATED 20 MILLION I SPOKE ABOUT IN TERMS OF THOMAS KRAMER' ESTIMATE, BUT IN 1989 WHEN THE FEDERAL GOVERNMENT STARTED TO TRACK WEALTH DATA, WHITE AMERICA ALONE HAD 21 IT TRILLION IN ASSETS.

BLACK AMERICA LESS THAN A TRILLION.

THE FEDERAL RESERVE SAYS WHITE AMERICA TODAY HAS OVER 120 TRILLION IN ASSETS WHEN BLACK AMERICANS HAVE LESS THAN 7 TRILLION.

FOR OVERALL WEALTH, WHITE HAS 85 PERCENT OF THE HOUSEHOLD WEALTH, THEY'RE 57 PERCENT OF THE POPULATION.

MEANWHILE WE'RE 12 PERCENT OF THE POPULATION AND WE HAVE LESS THAN 5 PERCENT OF THE NATION'S WEALTH.

HOW DO WE DECIDE WHO GETS THEM?

GERMANY WAS ABLE TO FIGURE OUT HOW TO GIVE REPARATIONS EVEN THROUGH YOUR OWN GOVERNMENT TO JEWISH PEOPLE ALL OVER THE WORLD. SURELY OUR CONGRESS CAN PROVIDE REPARATIONS FOR BLACK AMERICANS STILL IN AMERICA WHERE HALF LIVE IN THE SOUTH AND WE HAVE CLEAR CENSUS DATA THAT SHOWS US WHO IS WHO.

SUCH AS THE 1960 CENSUS SHOWED US BLACK IMMIGRANTS WERE TO THE RIGHT OF THE DECIMAL POINT.

RESEARCH SHOWS US HALF OF FOREIGN-BORN BLACKS CAME OFF THE YEAR 2000.

THEY DIDN'T EXPERIENCE SLAVERY FROM 1819.

THIS IS NOT ROCKET SCIENCE.

PLEASE DO NOT GET CONFUSED WITH THE PHRASES.

NONE OF THESE LABELS ARE SPECIFIC TO THE PEOPLE THAT BUILT THIS COUNTRY BY SLAVE LABOR.

THEY WERE LOCKED OUT OF WEALTH AND OPPORTUNITY AND AMERICA.

MAYBE YOU BELIEVE OTHERS SHOULD RECEIVE REPARATIONS.

IF YOU WANT TO INTRODUCE IT FOR ANOTHER GROUP, DO IT BUT TONIGHT IS ABOUT BLACK AMERICA.

THE BLACK ENTERPRISE, SAYS OUR WEALTH WILL SHRINK.

OUR UNEMPLOYMENT IS DOUBLE OF WHITES.

WE EARN A FRACTION ALMOST HALF OF EVERY DOLLAR OF WHITES, WE'RE TWICE AND LIKELY TO LIVE IN POVERTY.

THREE TIMES A LIKELY TO LIVE IN POVERTY.

IF YOU TAKE DEPRECIATING ASSETS LIKE THE CAR OR CLOTHES, OUR WEALTH IS A TENTH OF A TENTH.

LESS THAN HALF OF US OWN HOMES WHILE THREE-QUARTERS OF WHITES TO.

AND INCARCERATION RATE IS SIX TIMES HIGHER THAN WHITES.

OUR LIFE EXPECTANCY IS LOWER.

REMINDING YOU WE'RE 12 PERCENT OF THE POPULATION.

AND LIKELY DIE BY POLICE.

TEN TIMES MORE LIKELY TO DIE BY GUN RELATED HOMICIDES THAT WE SAW UP CLOSE AND PERSONAL WITH 16-YEAR-OLD TYREE SMITH WAS SHOT AND KILLED WHILE WAITING TO GO TO SCHOOL AT HIS BUS STOP. WHEN YOU THINK ABOUT REPARATIONS PLEASE DON'T STEREOTYPE US. DON'T SAY IT IS SOMEHOW OUR FAULT.

MAYBE YOU DON'T SYMPATHIZE WITH THOSE TODAY LIKE MY GRANDMOTHER AND GREAT GRANDMOTHER WHO LIVED THROUGH JIM CROW.

MAYBE YOU DON'T SYMPATHIZE WITH YOUR COLLEAGUES.

MAYBE YOU DON'T SYMPATHIZE WITH YOUR COLLEAGUES, WITH ME,

SYMPATHIZE WITH TYREE.

SYMPATHIZE WITH 8-YEAR-OLD LOREA AND ARIANNA.

AND THREE-YEAR-OLD TRINITY, MY COUSIN! ALL KILLED IN OUR CITY. ALL BLACK.

ALL DESCENDANTS WHO NEVER RECEIVED THE DEBT OWED TO THEM FROM THEIR ANCESTORS.

THIS BELIEF OVERVIEW DID NOT INCLUDE THE G.I. BILL OR THE SOCIAL SECURITY ACT, FAIR LABOR STANDARDS, THE BILL CLINTON CRIME BILL AND ENVIRONMENTAL INJUSTICE AND SO MANY OTHER TARGETS.

THIS VERY BRIEF OVERVIEW.

EVEN THOUGH IT DIDN'T INCLUDE ALL OF THAT.

I BELIEVE IT HAS ADDRESSED MANY QUESTIONS THAT SOME OF YOU MIGHT HAVE TONIGHT.

POLICY BROKE US AND POLICY MUST FIX US.

POLICY DID THIS, SO POLICY MUST UNDO THIS.

I ASK FOR YOUR SUPPORT AND IF YOU CAN'T SUPPORT AT LEAST HAVE THE CAPACITY TO NOT OPPOSE THIS.

A VOTE MEANS YOU'RE WILLING TO LISTEN AND LEARN MORE. WE TALK ABOUT THE SOLUTION TO WHAT IS HAPPENING IN BLACK LOUISVILLE AND KEEP IN MIND SOME DISPARITIES ARE SIGNIFICANTLY WORSE IN OUR CITY.

SOME OF US TALK ABOUT THE SOLUTION.

THE SOLUTION IS RIGHT IN FRONT OF YOU TONIGHT.

WITH THAT BEING SAID, A MOTION TO LIMIT DEBATE.

[APPLAUSE].

LADIES AND GENTLEMEN I'M SO GLAD YOU'RE IN THE AUDIENCE, I HAVE TO TELL YOU I NEED YOU TO BE QUIET.

THANK YOU.

PIAGENTINI.

>> THANK YOU, MR. PRESIDENT.

FIRST, I DO WANT TO DISCUSS A THE VICE-CHAIR OF -- OF THE EQUITY WHICH IS AN HONOR AND I WANT TO THANK PRESIDENT JAMES FOR PUTTING ME IN THAT POSITION.

WHERE IT IS SO HARD TO DEBATE TOPICS OF RACE IN THIS COUNTRY. BECAUSE AS EXAMPLE HERE, THERE'S AN ASSUMPTION THAT WE MAY DISAGREE ON THIS TOPIC, THERE'S A LACK OF SYMPATHY FOR THOSE THAT I KNOW AND LOVE.

THOSE ARE MEMBERS OF THIS COUNCIL.

IT IS SIMPLY NOT THE TRUTH.

THERE'S COUNCIL MEMBERS AND SPEAKERS WHO HAVE USED THEIR -- WHAT

I'LL REFER TO A DEMOGRAPHIC, OSTENSIBLY TO INCREASE THEIR FEE DAYS WHEN WE TALK ABOUT TOPICS, RECENTLY ABOUT CHILDREN, RACE, GENDER SO I WANTED TO COVER SOME OF THIS.

I'M IN AN INTERRACIAL MARRIAGE.

I'M A SECOND GENERATION AMERICAN.

MY WIFE IS AN IMMIGRANT.

WE WERE EDUCATED AT BOTH PREDOMINANTLY WHITE COLLEGE AND AN HBCU.

I HAVE ADOPTED DAUGHTERS WHO MEET THE CLASSIFICATION OF

COUNCILMAN ARTHUR AS AMERICANS DESCENDING FROM SLAVERY.

THIS IS THE FUTURE OF FAMILIES, INTERRACIAL FAMILIES ARE GROWING DEMOGRAPHIC.

WHO THINKS THAT IN MY COMPLEX FAMILY STRUCTURE THAT RACE IS NOT A COMMON TOPIC THAT WE HAVE TO -- TO HAMMER OUT.

UNFORTUNATELY, WHEN I EVEN MENTION MY FAMILY DEMOGRAPHICS AS I DID RECENTLY, I'M ACCUSED OF USING MY CHILDREN AS TOKEN BY A MAYORAL CANDIDATE IN LOUISVILLE AND I'VE SOMEHOW QUOTE EXTENDED WHITE PRIVILEGE TO MY DAUGHTERS.

THAT ACCUSATION WAS MADE BY A LEADER OF THE LOCAL ORGANIZATION THAT I SUPPORT WHO I CONTRIBUTE TO ANNUALLY AND HAVE BEEN THE ONLY COUNCIL MEMBER TO ATTEND THEIR LARGEST ANNUAL FUND-RAISER. TO SUM IT UP I WOULD ASK I ASSUME AND I'M GOING TO TALK ABOUT COUNCILMAN ARTHUR'S PASSION AND HOW IMPORTANT IT IS. HE'S COMING FROM A POSITION OF THOUGHTFULNESS AND TRYING TO -- TO UNDERSTAND AND DO WHAT HE BELIEVES IS RIGHT.

I ASSUME EVERYBODY ELSE ASSUMED THE SAME THING ABOUT ME AND OTHERS WHO MAY VOTE NO TODAY ON THIS RESOLUTION.

WE MAY DISAGREE ON THIS.

THIS WILL ALLOW US TO CONTRADICT TO SOLUTIONS MOVING FORWARD AS OPPOSED TO DIVIDING US ON SUPERFICIAL MEANS.

I CAME TO EVERY POSITION I'VE COME TO ON THIS COUNCIL BASED ON FACT.

I WAS THE FIRST REPUBLICAN TO SIGN ON TO THE NO KNOCK WARRANT LEGISLATION THAT COUNCILMAN GREEN PRESENTED.

IT WAS A CONVERSATION WITH COUNCILWOMAN GREEN AND BEING PRESENTED WITH THE FACT THAT PROVED IT WAS THE RIGHT THING TO DO.

IT WAS THE SAME WITH MY ADVOCACY AND OTHER INITIATIVES I WORKED WITH OTHER COUNCIL MEMBERS ON.

I'LL CONTINUE TO DO THE THINGS THAT ARE RIGHT.

I'M SURE ALL OF YOU WILL AND HAVE A PROVEN TRACK RECORD OF FIXING AND HEALING THIS CITY.

THAT BRINGS ME TO WHAT WAS COVERED DURING THE COMMITTEE MEETING. I WANT TO TALK ABOUT THIS A LITTLE BIT TO RECAP FOR THOSE THAT HAVEN'T SEEN IT.

I ENCOURAGE EVERYBODY, TWO COUNCIL MEETINGS ON THIS -- FIRST ONE WAS ALMOST ALL SPEAKERS.

THE SECOND ONE WAS OUR DEBATE AND I ENCOURAGE EVERYBODY TO WATCH

BOTH.

THERE WAS JASON CROSBY.

HE'S A MINISTER OF CRESCENT HILL BAPTIST CHURCH.

HE SPOKE OF THE BIBLE.

THE SECOND SPEAKER WAS COUNCILMAN ARTHUR'S REQUEST.

THAT'S THE VET CARNAL WHOSE PURPOSE IS FOR ADVOCATE FOR

REPARATION FOR SLAVES.

I ENCOURAGE EVERYBODY TO WATCH IT.

I APPRECIATE COUNCILMAN ARTHUR'S PERSPECTIVE AND THE SPEAKER AND THE UNIQUE VOICE THAT AGAIN COUNCILMAN ARTHUR HAS BECAUSE ALL VOICES MUST BE EXPRESSED FROM A LEGISLATIVE BODY.

FINALLY I HAD AN INVITEE WHO WAS DR. WILFORD RILEY.

HE HAS ACADEMIC CREDENTIALS AND BEEN PUBLISHED MULTIPLE TIMES. HE'S AT KENTUCKY STATE.

I WOULD ARGUE LOOKS MORE LIKE THE FUTURE OF AMERICA AS HE'S OF MIXED RACE.

WE DON'T ARGUE THE MORAL ARGUMENT FOR REPARATIONS.

THERE'S AN OBVIOUS MORAL ARGUMENT.

THEY SPOKE TO WHAT ARTHUR ADDRESSED TONIGHT, WHO GETS IT, WHO PAYS, WHO IS NEXT?

WHO PAYS?

THE ORIGINAL REPARATIONS OR THE FOUR ACRES AND MULE EXECUTIVE ORDER THAT WAS SIGNED BY LINCOLN WOULD HAVE COST TAXPAYERS NOTHING. THIS WAS OPEN LAND.

THESE WERE MULES LARGELY PURCHASED BY THE ARMY ALREADY, THEY WOULD HAVE DIED.

SO THE COMPLICATING ISSUE, THIS IS FAR MORE COMPLEX AS THE VAST MAJORITY NOW OF RESIDENTS IN THIS COUNTRY HAVE NO LINK TO SLAVERY DUE TO THE PAST 100 YEARS OF IMMIGRATION.

IMMIGRATION FROM AFRICA AND OTHER COUNTRIES.

FINALLY WHO IS NEXT?

NO PROBLEM.

WE WON'T DISCUSS, ALTHOUGH THIS WAS DISCUSSED FOR EXAMPLE ARE WOMEN OWED REPARATIONS.

THERE'S ZERO DOUBT OF THE ISSUES -- OF THE -- OF THE POOR TREATMENT OF A VARIETY OF GROUPS IN AMERICAN HISTORY. BUT EVEN IF WE FOCUS ON AMERICAN DESCENDANTS OF SLAVERY, ADVOCATES HAVE SPOKEN OF 2 TRILLION TO 20 TRILLION DOLLARS, THE

ENTIRE GDP OF THE UNITED STATES IS A TRILLION DOLLARS.

IT IS MENTIONED AS A DOWN PAYMENT.

IF WE DON'T KNOW -- IF THIS IS DESCRIBED AS A DOWN PAYMENT, WE DON'T KNOW WHAT IS NEXT RELATED TO THIS QUESTION.

NOBODY QUESTIONS THIS, THE BRUTALITY, IT IS NOT WHAT HAPPENED IN THE PAST BUT WHAT IT TAKES TO GET TO EQUITY OF OPPORTUNITY AS OUICKLY AS POSSIBLE.

HERE'S ULTIMATE QUESTION.

WHERE IS THE PROOF THAT THE REPARATION IS THE BEST AND MOST

EFFICIENT WAY TO RIGHT THE WRONGS.

WE SPENT 22 TRILLION DOLLARS ON THE WAR ON POVERTY WITH ZERO DEMONSTRATION OF SUCCESS.

I CAN CITE MULTIPLE ECONOMISTS WILLIAMS AND SEOUL WHO WRITTEN WHY REPARATION RESPECT A BAD IDEA.

THESE ARE BLACK PH.D.S WHO LIVED THROUGH JIM CROW AND THE WORST PARTS OF SLAVERY.

I WANT TO RECAP WHAT FORD SAID.

I GOT A COPY HERE.

I GOT AFU EXTRA.

IT HAS BEEN SAID THAT HB40 IS A STUDY OF REPARATION, IT IS NOT A WAY ON HOW TO RIGHT WRONGS.

IT IS DONE THINKING REPARATION WAS THE ANSWER.

THEY PAID A COMMISSIONER TO POINT OUT ONE OF MY ISSUES WITH HOW HB40 IS DRAFTED.

COMMISSION WILL BE COMPOSED OF 13 MEMBERS.

SHALL BE APPOINTED WITH THE 90 DAYS OF THE ENACTMENT OF THE ACT. SIX MEMBERS SELECTED FROM THE MAJOR CIVIL SOCIETY AND REPARATIONS ORGANIZATION THAT HAVE HISTORICALLY CHAMPIONED THE CAUSE OF JUSTICE.

ALL MEMBERS OF THE COMMISSION SHALL BE PERSONS QUALIFIED TO SERVE ON THE COMMISSION BY VIRTUE OF THEIR EDUCATION AN EXPERIENCE.

THERE WAS NO DEFINITION OF WHAT QUALIFIED MEAN.

THERE WAS NO CALL FOR EXPERT IN ECONOMICS.

YOU MAY WANT TO TALK TO HIM ABOUT BRIDGING THE WEALTH GAP. I LEAVE FOR ONE FINAL QUESTION.

WHEN IN THE HISTORY OF AMERICA HAS THE FEDERAL GOVERNMENT BEEN THE ONLY ONE THAT CAN STUDY A TOPIC.

IF WE'RE JUST SUPPORTING A STUDY, I'VE GOT A BETTER IDEA, FIRST, WHY DO WE HAVE ANSWERS TO QUESTIONS BEFORE THE STUDY IS STARTED? WHY DOESN'T HOWARD MOREHOUSE, SPELMAN, OUTSIDE OF THE HBCS, HARVARD, YALE, WE HAVE THE FINEST, THE HIGHEST DENSITY OF INSTITUTIONS OF HIGHER LEARNING THAN ANY OTHER COUNTRY IN THE WORLD.

INCLUDING OUR HBU WHICH ARE OUTSTANDING.

WHY ONLY THE FEDERAL GOVERNMENT?

UNLESS THIS IS NOT A STUDY AND THIS IS A STEP IN THE PROCESS THAT IS PREDESTINED REGARDLESS OF ANSWERING THE QUESTIONS I IDENTIFIED ABOVE.

BECAUSE OF THOSE REASONS, NOT BECAUSE MORALLY IT SHOULD HAVE BEEN DONE, NOT BECAUSE WE MUST DO MORE OR WE CONTINUE TO DO MORE THAN WE'RE CURRENTLY DOING BUT I BELIEVE WHEN YOU LOOK AT THE OUTSTANDING QUESTIONS, THIS IS NOT PROVEN TO BE THE BEST SOLUTION.

THERE COULD BE IMPACTFUL WAYS TO PROVIDE EQUITY OF OPPORTUNITY. NOT ABOUT STUDYING ONLY WHAT OTHER ACADEMIC INSTITUTIONS COULD DO BUT ASSUMING THIS SHOULD BE DONE AND STUDYING THE WAY TO DO IT, I'LL BE A NO VOTE.

THANK YOU.

>> LADIES AND GENTLEMEN, I WANT TO REMIND EVERYBODY THAT WE HAVE A MASK MANDATE IN THIS BUILDING.

IF YOU DON'T HAVE A MASK ON, I NEED TO ASK YOU TO LEAVE THE CHAMBERS.

>> I HAVE DOUBT.

I'M UNCLEAR.

I ATTENDED THE FIRST COMMITTEE MEETING.

THE SECOND ONE LAST WEEK VIRTUALLY, TWO HOURS OF WONDERFUL DEBATE.

TWO HOURS OF KNOWLEDGE AND LEARNING.

IT LEFT ME WANTING MORE.

I'M GOING TO CONFESS AND GOING TO BE BOLD AND CONFESS THAT I SIMPLY DON'T KNOW.

I'M NOT CONVINCED THAT REPARATIONS IS -- IS THE ANSWER.

I'M NOT CONVINCED THAT REPARATIONS WILL ACHIEVE THAT WHICH -- WE NEED FOR IT TO ACHIEVE.

SO I NEED TO KNOW MORE.

THERE'S STILL DOUBT.

THERE'S STILL APPREHENSION.

FEAR OF THE UNKNOWN.

WHAT DOES A REPARATIONS PROGRAM LOOK LIKE?

A NATIONAL REPARATION ROLLOUT.

YOU DON'T KNOW HOW THAT WORKS.

AND COUNCIL PIAGENTINI USED A DOWN PAYMENT REFERENCE OF DOWN PAYMENT.

ALL OF THIS TIME I'VE BEEN THINKING OF IT IN MY OWN WAY.

I WAS THINKING LIKE SETTLING OUT-OF-COURT.

THAT'S NO GOOD.

YOU SETTLE OUT-OF-COURT, YOU ACCEPT A CHECK, ISSUE OVER.

THIS ISSUE AIN'T OVER.

HOW IN THE WORLD CAN WE LOOK AWAY FROM THE HORROR, THE NIGHTMARE AND THE -- AND THE INDIGNATION OF SLAVERY AND THE EFFECTS IT HAD ON ALL OF US TO THIS VERY DAY.

IT WILL NEVER GO AWAY.

I NEED TO KNOW MORE ABOUT REPARATIONS.

I'M HUNGRY FOR MORE.

SO ALL THE MORE REASON TO SUPPORT THIS MEASURE.

TONIGHT MR. PRESIDENT, I WILL BE VOTING YES FOR THIS RESOLUTION.

I AM -- I ENCOURAGE EVERYONE TO BE BRAVE, CONFESS THAT

YOU -- YOU NEED TO KNOW MORE.

WE ALL NEED TO KNOW MORE.

AND MS. PARKS WAS RIGHT.

SHE SAID THE EYES OF AMERICA ARE ON US.

SHE'S RIGHT.

LET'S DO SOMETHING BRAVE.

I FEEL AS TRIPLETT SAID THAT COUNCIL IS TO MAKE BOLD STATEMENTS. TIME FOR THE REST OF THE COUNTRY TO SEE THAT WE ARE MOVING FORWARD WITH THIS.

AND OR CITIES WILL JUMP ON BOARD.

AND SO I WOULD DEFINITELY BE A YES VOTE, AND ALSO LIKE TO REQUEST TO BE A SPOKESPERSON.

I FEEL GRATEFUL TO BE MY COLLEAGUE.

I FEEL MORE GRATEFUL THAN NORMAL.

THAT WAS A TRULY IMPRESSIVE PRESENTATION AND I FEEL GREAT TO WORK WITH HIM.

I'M EMOTIONAL BECAUSE I FELT THE WEIGHT OF WHAT HE WAS SAYING A HE SPOKE AND THE WEIGHT OF WHAT HAS BEEN BROKEN AND THE WEIGHT OF THE HISTORY AND HOW IT COMPILED UPON US TO GET US WHERE WE ARE TODAY.

I FEEL ITS HEAVINESS AND I WANT TO KNOW WHAT WE COULD DO ABOUT IT.

I WANT TO KNOW MORE AND BE PART OF THE SOLUTION AND I WANT TO UNDERSTAND WHAT I COULD DO AS A PART OF THE PROCESS, WHAT OUR GOVERNMENT COULD DO TO RIGHT THIS WRONG.

THESE ARGUMENTS I'M HEARING TONIGHT ARE A RED HERRING, QUITE FRANKLY.

THIS RESOLUTION CALLS FOR A COMMISSION OF SMART AND QUALIFIED PEOPLE TO STUDY THIS ISSUE FURTHER.

IT GIVES THEM THE RESOURCES THEY NEED TO ANSWER THE QUESTIONS THAT COUNCILMAN PIAGENTINI FEELS SO DESPERATELY HE NEEDS ANSWERS TO, LIKE HOW TO IMPLEMENT THIS PRACTICALLY, WHO GETS IT AND HOW AND WHY.

I THINK WHEN WE PUT SMART PEOPLE IN A ROOM TO FOCUS ON THESE, THESE ARE NOT HARD TO SOLVE.

WE'VE SOLVED THIS FOR OTHER GROUPS.

I BELIEVE WE CAN ADDRESS THESE PRACTICAL ISSUES.

IT IS NOT OUR JOB TONIGHT TO ADDRESS THEM.

TONIGHT WE'RE EXPRESSING SUPPORT FOR CALLING TOGETHER A GROUP TO TACKLE WHAT IS SIMPLE AND AT ITS CORE AND IS RIGHTING A WRONG AND UNDERSTANDING A PATHWAY TO THAT.

GIVING SMART PEOPLE THE TOOLS TO FIGURE OUT THE COMPLEXITY. I HEARD THE QUESTION IS THIS IT THE BEST WAY TO RIGHT HISTORIC WRONGS?

I WOULD SAY WHAT OTHER OPTION IS THERE.

WHEN SOMETHING IS BROKEN, IT IS IT INCUMBENT UPON US TO REPAIR IT.

THE FEDERAL GOVERNMENT THROUGH CENTURIES OF POLICY BROKE A PART OF THE POPULATION IN THIS COUNTRY.

AMERICAN DESCENDANTS OF SLAVES ARE SUFFERED FOR CENTURIES BECAUSE OF POLICIES.

IT IS INCUMBENT ON US TO EXPRESS SUPPORT FOR UNDERSTANDING HOW WE CAN SOLVE THE ISSUES OUR GOVERNMENT CREATED.

SOMETIMES WE ALLOCATE LIMITED RESOURCES AND WE FIGURE OUT HOW WE'RE GOING TO IMPLEMENT PROGRAMS.

WE DO NOT HAVE TO DO THAT TONIGHT.

WHAT WE DO TONIGHT IS EXPRESS SUPPORT FOR AN IDEA.

THEN OTT SOURCE THAT TO SOMEBODY ELSE TO GET THE THINKING AND IMPLEMENTING AND HARD WORK.
