I am a proud Louisvillian and a Kentuckian who has worked throughout my professional career to share my love of my home with our brightest young minds so they might stay here. I moved to Louisville from Southern Kentucky in 2003 to attend UofL, and that decision was formative for me. I believe in the spirit and the people of this city, and am committed to doing the work of moving it forward. It is my honor to offer my services to the 6th District.

I committed the first chapter of my career to civics education because I believe in its power. I spent 13 years working with teens through the Kentucky YMCA Youth Association. In that time, I helped organize over 150 large-scale conferences serving between 50 and 2000 teens each (including Metro Youth Advocates, a program designed to advise Metro Council, JCPS, and other governing entities in the Metro area); I directly supervised a 3-person staff team that recruited over 12,300 students per year from 300 middle and high schools across all 120 counties around Kentucky, generating revenue of roughly \$1.25 million per year; and I personally managed a region of 30+ counties and recruiting over 7,000 students per year for revenues of over \$650,000 annually.

After a brief stint running the internship program for Northwestern Mutual's Hurstborne office (a role that was not my passion, but that did help me become better connected in my community), I took on a role as the Assistant Director of Admissions at UofL's Brandeis School of Law, where I'm doing work I sincerely love. It is wonderful to facilitate the process of bringing the brightest minds to our community to study law in an environment that prioritizes public service.

I am a self-starter, and a skilled presenter, researcher, and trainer, and I am committed to my community. I am creative at my core, a quick critical thinker, and a born team builder. I will always strive to innovate and improve the programs and organizations I lead and support. Above all, I believe in relationship building, and so I have developed a diverse and wide ranging network in my city. I am active in all facets of Louisville life. When I am on the Council, the citizens of this city will have an advocate they can trust, who will work to ensure their success and develop their full potential.
