Chief Little and/or Major Nalley,

I'm not sure which one of you would be the appropriate contact to discuss proposed developments in your district, so I'm including both on this email. We recently presented this at a public hearing in front of a subcommittee of the Planning Commission and Commissioner Carlson (former Fire Chief) asked that we reach out to your fire district to see if you had any issues with the proposed layout. His concern was the one access point over the stream to reach the 7 buildings at the rear of the property and wondered if we needed a second crossing there. The design team's opinion was that the one crossing was adequate since the rear buildings don't exceed the 200 unit threshold for requiring a second access point (there are 168 units in the rear) and we'd also prefer to minimize the impact to that stream and the associated cost with a second crossing.

Please review and let us know your thoughts. I'd be happy to answer any questions you may have.
