Windsor Park update:

The bids for design of Windsor Park opened on 11-03-22 and are being evaluated by the Parks & Recreation Engineering & Planning Division. We hope to have the initial evaluation completed by 11-16-22 and move onto the second phase of the evaluation later this week.

Although the design contract has not been awarded, we anticipate the design document portion of Windsor Park to be about \$80,000. It is not funded at this time, but we plan to incorporate space for a new playground to be adjacent to the restroom and sprayground as we go through the design process. Based on other similar sized playgrounds we have recently purchased and installed, we expect the playground phase of the project to be about \$100,000. Because of the proximity to of a heavily wooded area, we believe we will be able to incorporate some "natural" playground elements as well to enhance the more traditional playground unit. This idea/concept would be something similar to what have recently done at Tyler Park with the combination of traditional playground elements and the natural playground elements.
