Mr. Burton, who is 81, was once asked about hanging up his spot, he responded "where would my friends go, how would they continue to see each other." This is one spot that continues to put smiles on faces and joy in others hearts.

Ann Wagner - Mrs. Wagner has been a prominent figure in the Shawnee Neighborhood for at least 50 years. She has been the recipient of many awards and acknowledgements from mayors, governors, President Obama, NAACP, and others. She has worked with past aldermen such as Paul Bather, always around to lend a helping hand. It's time to honor her with an honorary street naming.

Greg Allen - Mr. Allen is retiring from the United States Postal Services after 40+ years.
