

I had previously sent the below emails to Sergeant Keeling and was advised, you would be my point of contact for the overtime hours for speeding.
We keep getting request for taking radar on streets. That is why the councilwoman is subsidizing another \$4,000.00 for a total of \$11,000.00 for this cause. These 2 NDF are separate from the other overtime funds that was provided for the weekend detail.

I have another street to include **Paramount Dr.**

This will make a total of 13 streets we now have on our list, that we would need detailed reports.
I believe taking radar in later afternoon and early evening would be a good option, however, I am leaving this to the experts. We would like to make sure providing this money for overtime was a wise decision.
