I apologize for the delay in messages. We have received a quote for the sidewalks in Glenmary Reserves. We were surprised as the cost for repairing sidewalks has doubled due to concrete and labor costs. As a result, Councilman Engel is still interested in supporting this project. However, he is first going to see if he can get the repairs into this upcoming budget as a line item. If this is not possible he will then pursue funding these repairs with a Capital Infrastructure Fund in July, following the conclusion of the Metro Council Budgeting process, and beginning with the new fiscal year 2023 budget. Once all of these steps conclude we would expect Public Works to be able to start repairs sometime next year before June $30^{\text {th }}$. Please be aware that this project is weather permitting and subject to Public Works project load.

Thank you so much for the quick response! Please keep me updated regarding the decision from Public Works and if you have any additional information regarding assistance that may be available to both owners and the HOA to help cover the cost of repairs/damage, that would be greatly appreciated.

The gentleman fell at the sidewalk located in front of 8701 Sanctuary at the corner of Providence and Sanctuary. I have also attached pictures that the Board President snapped of other sidewalks that we believe need critical attention.
