**MY TOPIC IS: CONSPIRACY BY LMPD, GOVERNMENT OFFICIALS, & BUSINESSES**

**LG&E** Representatives without ID put a Recorder on my home. Police Headquarters refused to take a report and I was stomped by the Louisville Metro Police. **(A Cover up begins)**

**County Attorney's** Office faxed a fax to themselves and stated it was from my neighbors. The fax states I am spitting on cars & a danger. (My neighbors did not send the fax and the County Attorneys fax number is at the top as the sender).

**LMPD** sends 30 Hate/Sexual Degradation/Death Threats Emails to me calling me Niggers and Slaves and threatens to kill me and my family.

**LMPD** confesses in writing & audio that they sent 2 men to Murder me. Video of white guy they sent at my front door is on my website.

**LMPD** confess in writing that they fabricate/forged documents in my name and that they are in my internet, phone, have key loggers to my computer and send things from my IP address.

I ask **Greg Wolfe** for help at the **Department of Criminal Investigation** in Frankfort, Kentucky and he threatened me.

**Tim Melton (Manager) at Louisville Gas and Electric, David Millay (Security) and LMPD** create a fabricated/forged email in my name stating I have a gun and I am going to kill Tim Melton. This email threat to Tim Melton appeared after I told him by telephone that I was going to report him to PPL, his Corporate Office.

**Jeremy Livers/Police Officer** (whom I have never met) filed a false MIW stating I threatened to kill Tim Melton of LG&E and tried to have me committed for the document they created. I did not open my door and it was thwarted.

**LG&E** came and illegally installed poles and connected 5G Verizon to my home. (Frequencies are sent through my home killing one of poodles, causing burning in my body and burning my kitchen floor). I filed against Verizon with FCC and Verizon responded they **did not install anything but LG&E did**. LG&E came and took the 5G down, however LG&E has put Risers underground on my property, installed fiber optic under the sidewalk in front of my home and a third hole. To Whom It May Concern,

This letter is concerning an individual named Connie Marshall. **Please forward this fax to the attorney prosecuting Connie Marshall's Case.** It is my understanding that Ms. Marshall is currently being prosecuted by the County's Attorney's Office regarding criminal activity against the Louisville Metro Police. I live on South 23<sup>rd</sup> Street, the same street Ms. Marshall currently lives.

Within the past several days, Ms. Marshall has been going up and down the street, spitting on people's cars and raving about the Louisville Metro Police Department. She has threatened violence against the police and made a variety of threatening remarks against the police department and other people on our street. Having talked with a few other neighbors further down the street about this matter, we are all now concerned for our safety and for the safety of the police department.

Ms. Marshall's threats have escalated, where she is now threatening to physically harm herself and others, and that she is "oppressed" by the police department. She has also started banging things to get people's attention to signs she has made and spitting on people's vehicles.

I ask the County Attorney to please do something about this woman! She swings from good days to bad days. When she is having a bad day, it is now to the point that people are afraid to let their children out around her and we are actually living in fear. We have filed complaints with the police, but usually by the time they are here, she has locked herself in her house and screams at 11pm.

Further investigation by Verizon's network team confirmed that LG&E did move forward with work on their own poles and lines in preparation to accommodate the future installation of Verizon equipment. Please note, however, that our 6/15 response remains accurate. To date, Verizon has not attached any of our equipment (including cables or wires) to the LG&E poles.
