#### What happens when a camp is reported through Metro 311?

Risk Assessment Offer Services Mitigate Hazards Remediate Camps Prevent Re-establishment

#### Risk

A Risk Assessment evaluates the health and safety hazards posed to camp residents and the neighborhood.

#### Outreach

Outreach teams are notified, so they can assess residents' needs, provide resources, and offer services.

#### Clean

The Encampment Clean Collaborative is a partnership of Louisville Metro agencies and service providers to pick up trash from and around the camps.

#### Clear

When a camp needs to be cleared, HSD follows the 21-Day Ordinance and a State MOU. HSD then coordinates the relocation of camp residents and clearing of debris.

#### **Prevent**

Outreach teams provide a consistent presence in areas that have been cleared to offer services and discourage re-establishment.

# **HSD Protocol**

- HSD coordinates activity among partners
  - Outreach
  - LMPD
  - SWMS
- LMG does not clear camps during White Flag conditions
- HSD does not condone camping
  - Excludes camping equipment from reimbursable expenses

# Timing: CAMP ESTABLISHMENT

LMCO 131.01-131.03

CAMP or CAMPING. Means the use of public land or public premises for temporary living accommodation purposes by the occupation or habitation of an area, location or property through the use of temporary shelters, recreational vehicles and/or camping paraphernalia. In no event may a camp be established in less than 48 hours.

#### **Impact on Response**

Changing the time period would allow more time for HSD to respond and coordinate with other agencies. This also requires clarity on the start time.

# **Determination: CAMP**

LMCO 131.01-131.03

CAMP or CAMPING. Means the use of public land or public premises for temporary living accommodation purposes by the occupation or habitation of an area, location or property through the use of temporary shelters, recreational vehicles and/or camping paraphernalia. In no event may a camp be established in less than 48 hours.

# **Determination: PERSONAL ITEMS**

LMCO 131.01-131.03

PERSONAL ITEMS. Means any item that is reasonably recognizable as belonging to a person and has apparent utility and does not include items that have no apparent utility or in an unsanitary condition, including, but not limited to, identification documents, birth certificates, and other personal documents and effects.


### **Determination: ABANDONED PROPERTY**

LMCO 131.01-131.03

PERSONAL ITEMS. Means any item that is and has apparent utility and reasonably recognizable as belonging to a person does not include items that have no apparent utility or in an unsanitary condition, including, but not limited to, identification documents, birth certificates, and other personal documents and effects.



# Repercussions: DISCIPLINARY ACTIONS

LMCO 131.01-131.03

Any Louisville Metro employee found to be in violation of this subsection may be disciplined, up to and including termination.

#### **Impact on Response**

Metro Government employees have apprehension about executing the ordinance without protective standards.



## **Enforcement: SIGNAGE**



#### **Impact on Response**

LMPD has asked JCAO to clarify enforcement of No Camping signage.



# **Enforcement: SIDEWALKS**



#### **Impact on Response**

LMPD has requested legal clarity about how and when they can require encampment residents to vacate sidewalks without a 21-day notice.

## **Enforcement: PARKS**

#### **LMCO 42.32**

CLOSING HOURS FOR PARKS AND PLAYGROUNDS. The parks and playgrounds of Louisville Metro shall close at 11:00 p.m. and shall remain closed until 6:00 a.m., and, with the exception of nonstop through traffic only, overnight camping in areas designated by the Director of Parks, or by written permit from the Director of Parks, it shall be unlawful for any person other than police, fire and other emergency service personnel, public utility personnel, and Parks Department and other Metro Government agency personnel, while on official business only, to enter upon any park or playground of Louisville Metro during hours when such park or playground is closed.

#### **Impact on Response**

Presence in Metro parks is enforceable when they are closed between 11:00pm and 6:00am.
