"Chair Dorsey"

2nd Dorsey. Who do I have here to speak to this item?

"Alex Mercer"

Hey, good afternoon. Alex Mercer economic development with level.

4 is speaking on behalf of Jane nipper and company incorporated. So, Jay never founded a 986 and Lakewood, New Jersey. It's a pharmaceutical distribution group, handling drug samples and marketing materials for 90% of the major brands in the U. S. they supply.

of the major brands in the u s they supply

To physicians and pharmaceutical reps throughout the country, and they actually have a major distribution center, right across the river in river ridge.

They actually just expanded that distribution center last year to the tune of around 20Million as well. So they're grown here in the region.

They're good company with this project here in mobile, though, they have established a back office support center at 2700, blankenbaker Parkway in council district.

11 here, they've invested over 4Million dollars to outfit their office space, and we'll hire up to 182 full time employees by this 10 year requirement for their incentive package. And so.

this ten year requirement for their incentive package and so

Like, I mentioned a great company, they've been grown here for a while, and little forward supports the project and we look forward to answering any questions.

"Chair Dorsey"

Thank you, Alex. I did receive a couple of questions in advance 1. what is the do you have the majority makeup of this company? When you, I'm sorry, the minority percentage of this company,

"Alex Mercer"

they're not right now.

"Chair Dorsey"

Okay. And then it said at the onset of the application, there were 33 full time roles and then it gave the incremental years. Where are they at now?

"Alex Mercer"

As far as and where they at, as far as the incremental years so what they have to do in order to be 100 eligible for the incentive package that's on here on the border port, which is. which is 2Million dollars, they have to be at at least 10% of 96, total employees on that. 1st year job target. And so, right now they're sitting right or down 8,586 and so they are pretty right there with with what they. Said they were going to do about 2 years ago in 2020.

"Chair Dorsey"

Okay, and then last lastly, reading over the application, is this an expansion or a relocation?

"Alex Mercer"

This is actually a relocation. Trying to think yeah, it's not on here the original location, but yeah, so this is a new site for them.

"Chair Dorsey"

Okay. All right. Those are all the questions I received in advance. Madam Clark is there anyone in the queue?

"Olivia Bennett"

No, ma'am, there is not okay. Anybody want to wave their hand.

"Chair Dorsey"

Sometimes there's a delay in here, I don't see anyone in the queue here. This is a resolution allowing for a voice for all those in favor. Signify by saying, aye.

I all those opposed resolution passes, Madam please move this item to consent. Please proceed to item number 3. Thank you.

Item number 3 is our dash 130 dash 22 a resolution pursuant to the capital and operating budget ordinances, approving the appropriation to fund the following non competitively negotiated professional service contract for local metro police department concerning forensic medical services for abused and neglected children.

Norton children's medical group LLC for 125,000 dollars, right? In full

"Matt Mayor"

Afternoon Thank you. My name's Matt. Mayor, I'm the major of major crimes for the metro police department so.

I'm here on behalf of to talk about the.

Program or the safe program.

I would get some of these acronyms out of the way the same program. Um.

The sexual assault nurse examiner safe program is is sexual assault, forensic examiner services.

Um, basically safe is the program and the same nurses.

Administer the examinations and basically.

Without these forensic examinations, we would not be able to make a case in court.

These examinations offer either cooperation or contradiction to the stories and the investigation that we have.

Um, without this independent medical.

Examinations we evidence we would not be.

Where we need to be in court, so we're fully support of these funds and hopefully they will be awarded.

"Chair Dorsey"

Yes, thank you so a couple questions 1, assuming that this is so source because Norton is the primary pediatrics facility within the region is that correct? Okay.

And I assume that just when, when looking at it 1 question in regard to this is number 3, the compensation per hour, there was a question about 300. hundred

Excuse me, it's a 300 bill, 300 dollars per 14th hour. Increments. Is that 300 per every 15 minutes in regard to operations?

"Matt Mayor"

That's why I understand.

"Chair Dorsey"

Okay and then the last 1, the training that's available there is a difference between these 2 contracts. This 1, and the next 1, we'll look at this 1 makes training available for all officers.

Is that at no cost to them as a part of the contract? Is that a segment. is that a segment

Of or is that all of, or anyone who wants to take advantage of that training?

That's what I assumed. All right, those were all the questions Madam clerk is there any 1 in the queue?

"Committee Member Holton Stewart"

what I have a question.

"Chair Dorsey"

Go ahead.

"Committee Member Holton Stewart"

Madam chair I believe.

I'll read the contract as build, um, as 300 dollars per hour that build in quarter hour increments.

Meeting meaning that, uh, every 15 minutes, they would build up to 300 dollars per hour. So.

Maybe I'm reading that wrong, but that's how I'm reading that.

"Chair Dorsey"

Yes, ma'am. That's why I asked for the clarification. Was that 300 every hour or 75 an hour.

Or, I'm sorry, 75, every 15 minutes. So that that was the question that came through.

"Matt Mayor"

Yeah, so if you're asking me to answer that question, I don't have that. Answer at this moment,

"Chair Dorsey"

that's fine. If you would just email us that clarification. I been in the hospital before. So even at 300 that doesn't seem far fetched with all the different staff and protocols. I have have to go through. through

Full disclosure from a hospital administrator here so I understand that, but just for the clarity of the, the public 1 other question that I did happen to overlook. Do we know what the number of cases were? Last year?

"Matt Mayor"

I asked for that, and I didn't get a specific number, but we were thinking about half of all of our cases.
Go through this program.

"Chair Dorsey"

Okay so about half.

Wow, okay. All right. Are there any other questions

I just want to say on the record. This is highly important when we talk about children and what that means is as a child being abused, and I'm in support of this program. And I'm grateful that we do have Norton here in the region to be able to handle this for our.

So I'm very much so. And supported this. I think all of the committee members are, this is a resolution allowing for a voice vote, all those in favor signify by saying, aye.

"Stephanie Moore"

Hi, I'm Stephanie. More assistant director with the local zoo.

Um, this is an amendment to the contract. We had our incredible bugs insect display over the summer, and in the original contract shipping and installation was listed as an item to be built later.

And this is the follow up bill for that shipping and installation. That was not specifically with the dollar amount listed in the original contract.

"Chair Dorsey"

So, is that the reason why it is considered sole source at this point?

"Stephanie Moore"

The original contract was a sole source with so it's just an amendment to that because it's for the shipping of the of the insects.

"Chair Dorsey"

Okay, and how long have we had this partnership with Donald? On?

"Stephanie Moore"

This particular display was on exhibit from June 18th through September 18th.

We also had a dinosaur exhibit with them last year.

"Chair Dorsey"

Okay, and a question, it may be the county attorney could help with this in regard to the do not exceed amount of 1 is listed as 152. the other is listed as 302. do we know what the actual do not exceed? Is.

"Stephanie Moore"

382 would be for the original payment for the actual rental of the exhibit. The additional 157 would be the shipping and transportation and installation costs. Okay. So the 152 in total would be the correct total for the correct.

"Chair Dorsey"

All right, thank you so much.

All right, and just a question, and if you can't give this away because of proprietary secrets, I completely understand how much longer do we expect to have this particular exhibit on display

"Stephanie Moore"

this exhibit closed September 18th? So the bugs have all blown away. away Um, to their next location, and we hope to be able to announce what we're gonna have next year shortly.

"Chair Dorsey"

Awesome. So we are closing this 1 out. This is just the fulfillment of the shipment back. Awesome. Um, councilmen.

"Vice Chair Engel"

And you Madam chair just a real quick question and I was zipping through this thing. Where is this? Where are they shifted? Where is this shipping from

"Stephanie Moore"

originally shipped to us from China so they came over on a freight. On ships, and then we're trucked to us from the West Coast

"Vice Chair Engel"

and that's a significant shipping cost.
I guess if it's coming from China that we're that's significant. Thank you.
Thank you very much

"Chair Dorsey"

as a follow up to that is a really good question. You all do account for the shipping in your budgeting when you do that. Okay. Just wanted to make sure that all right. Are there any other questions? Adam Clark is anyone in the queue? Oh, man.

See, who do I have here to to speak to this item?

"Matt Mayor"

Matt, Mayor made your friends a little metro police.
It's basically the same thing that we just went through through the kids earlier, but this is for adults. Um.
Same thing if we didn't have this partnership.
Um, we wouldn't have much evidence to go to court with.
They do the examinations it's the number 1 way we prove course cases in court.
And it again provides that independent scientific medical evidence that we need for our cases.

"Chair Dorsey"

Hey, Matt quick question. Is there a reason why we go through the university versus we do have so we do have use Norton for the pediatrics portion of this. Is there a reason why we go to the university for the adult portion versus all?

All of its staying at Norton, if there's equipment and all that other stuff involved.

"Matt Mayor"

We've had that partnership with university. Um, I'm not sure. Um. Why exactly other than we have that partnership, we've had it for years and. We've always used them do we know if Norton healthcare has a similar program?

"Chair Dorsey"

I do not okay any other questions.

"Committee Member Kramer"

Sounds good, thank you. Much here. Um, major. Is it safe to say that? Um.

Most of our, I'm trying to think of the proper term for it. Um. Is it safe to say that that most of the. The injuries that result from violent Crem that those patients end up at the University of hospital University of the hospital.

"Matt Mayor"

It is that's the number 1 trauma center we go to.

"Committee Member Kramer"

Let's say, thank you. So, that was the 1. I was like, for so the number 1 trauma center and if I'm not mistaken, this is a, this is not a new contract for us. Right? We've, we've had an arrangement like this with the university for quite a number of years, right? In that memory.

"Matt Mayor"

Yeah, it's my understanding we've been in this for I mean, I asked and somebody said they thought a decade.

"Committee Member Kramer"

Yes okay. Thank you. I just again, I would point out that it's the major trauma hospital in the, in the community and. Unfortunately, whether we like it or not the victims of a lot of these crumbs. Are already in that hospital and so having a partnership with them just seems to make a lot of sense. And while I always appreciate asking questions, a sole source contract but I think sometimes we. Getting the habit of doing it, because it's easy. Um, this 1 seems to make a lot of sense. So I appreciate you being a major. Thank you.

"Chair Dorsey"

Thank you I think I understand that very well. My clarification was this is sexual assault and not necessarily the we go to university level for actually, what does it room? 5? Yeah a room 9 for most of the gunshots. So this seemed a little bit less traumatic. So, that's why that question was in regard to why University versus northern healthcare, and also to have transparency across the board. So, if that is because of the trauma center, then that is the case. But I do think it's important that we ask those questions and then we get those out there. Do you want to add any additional explanation?

"Matt Mayor"

I do not. Okay.

"Chair Dorsey"

All right so, for the record, we are still sourcing this because university level is the region's number 1 trauma center and so with that being said, even though this is sexual assault, we are going to keep that synergy going. All right, this is a resolution allowing for a voicemail, all those in favor signify by saying, aye aye, those opposed this resolution classes clerk please move this item to consent. Let's move on to item number 6. please.

On number 6 is our dash 10,422 a resolution pursuant to the capital and operating budget ordinances, approving the appropriation to fund the following non competitively negotiated professional service contract for Metro, safe concerning project analysis and evaluation of a pilot 911 call prioritization program. University of Louisville. For 623,514 dollars in full

"Chair Dorsey"

motion to approve 2nd door. See, who do I have to speak to this?

"Jody Meiman"

Hello Jodi MAM and the executive director for a local metro emergency services. We appreciate the opportunity to come back and speak on the resolution. So, as you. metro emergency services we appreciate the opportunity to come back and speak on the resolution so as you All know, is council members, we started a pilot program on March, the 21st diverting our mental health crisis 9 on 1 calls to a group of behavioral health specialists that sit in our 911 center. I'd like to just share just a couple new statistics that have just come out this week to date. We've had 484 calls that have went to those what we call and the 901 center, and 91% of those calls have received some

type of resources, or been referred to other entities within the community.

So that's a really big number. And it's something that we're proud of so, this contract that we're seeking today, sole source contract and I know there's some issues and some questions about so sourcing but when we decided to do this pilot project, we contracted the university a little to come in and evaluate the project to get them in the door to evaluate this meant significant amount of training, it also included a significant amount of approvals to get people just in the door to be in the 901 center as far as background checks. as background checks And things like that, so they evaluated the 1st, part of the pilot program.

They produced a document midsummer that all you all have received a copy of, and the ideal to this was to contract with them again, to evaluate the entire fiscal year that you on the for the same budget the time that you all approve the budget for. So it would last throughout the year, they would also go back to July or 2. actually, it's going to go back through May because their data stopped, they stopped.

Giving data in May about halfway through so that they could produce and get the report out on time.

So, they're going to go back where they left off, start extracting that data and then produce the reports moving forward and continue the evaluation process and eventually give us recommendations on how to move the project forward.

"Chair Dorsey"

Thank you Jodi what year are we in this program?

This is about 5 months into this program. So, like I said, we started March, 21st of 2022.

"Chair Dorsey"

Okay, secondly, um, can you.

Maybe delineate a little bit more as to why we just chose to partner with the university versus bidding this out and then doing their training. I do know that there are, you know, potentially other entities. That can do program evaluation.

But specifically, why the University of Louisville and their, I guess, more stringent adherence to scientific protocol, et cetera could you delineate on that for the public?

"Jody Meiman"

The initial idea was bringing them into the pilot to evaluate the initial part of the pilot project was they had they were a big part on producing the recommendation for the pilot project itself.

So, they had already been trained on how to extract the data from our computers anyway. So that's why we contracted them to do that. And then

it just makes sense as well to move forward because they already know that if we had to bring another contractor in to do this. Um, we would talk about a significant amount of time and delay up to several months to train them and get them into the system where they could get that data out.

"Chair Dorsey"

So, Jody, if we delay this, potentially, we would not be able to provide those services to the community. Correct?

"Jody Meiman"

We would continue providing the services, but we would not have somebody, uh, evaluating it real time to show things that we could potentially be missing.

"Chair Dorsey"

Okay. So we could continue to to administer services, but we would not be able to have the quality control. Okay.

So, when it comes to the evaluation, how often are they coming in? Is it real time every 3 months? Are they sitting there beside the 911 dispatchers? How how are they offering and providing these recommendations?

"Jody Meiman"

I've really got to know Dr Shafer very well because they're. because they're

They're always in our shop there with there were 7 county services who we contracted. So they're if they're not with us, they're with 1 of the other entities. So it's constantly moving project.

"Chair Dorsey"

If we were to build this out, and we have a delay a little bit in the programming project administration. How would that process look.

"Jody Meiman"

Uh, it would be, it could be up to 6 months before we even get back into it. Like I said, if we bid it out, you're talking about that process and then the amount of time, once we award that bid to get them back into the system to learn how to do everything.

And, like I said, vetting the people to even get into the system, sometimes produces problems.

Because of our, our security level that we have inside the 901 center, and all the data that we collect.

"Chair Dorsey"

Thank you, Jodi, anyone else with any questions another question, Jodi,

about how long I know this council was was very forward and progressive about making sure that this was funded about how long do we expect to keep this program going? And I know there were even some recommendations in regard to expanding it.
Can you delineate that as well?

"Jody Meiman"

I would say forever, I mean, it's a really good program. We've seen that it helps people already. So, um, up is the only place in my mind that we've got to go.

"Chair Dorsey"

Okay, all right any additional questions.

All right, well, 1st of all let me.

Let me say, thank you. I am very appreciative for the work in regard to deflection.

I actually expect it to increase in reading about the number of mental health cases that we do have, and being able to divert the appropriate response to those calls is nothing, but just amazing in this community and also being able to use police as they should be used and not a mental health cases where really it's more of a public health.

Intervention more so than a, um.

The more so a safety from a, from a crime intervention. So I, thank you all for doing it.

I think the University of Louisville for doing that research, and offering those recommendations, Jodi, 1, last question, in regard to recommendations,

there was a question from the public in regard to the University offering recommendations and doing the program evaluation. Can you explain if there is any potential conflict of interest there?

"Jody Meiman"

I do not see any.

"Chair Dorsey"

Okay. All right. Thank you so much.

"Jody Meiman"

And I, thank you for the trades. If I go ahead. If I could just add 1 thing, the council is owed a a monthly report, not only a monthly report, but a quarterly budget report.

And then that too, you'll see the future expansions that are going to happen here in the near future as well.

"Chair Dorsey"

Thank you. All right. Okay. Go ahead.

"Cathy Duncan"

Good afternoon. Good afternoon. I'm Kathy Duncan. I am serving as the
assistant chief to chief. Amy has formerly chief Matt golden for public
services. This contract is a little bit unusual in that.
We discovered in June that Dr Williams contract with you about, had not
been vetted through or approved through the process once it terminated in
September.
October August 31st September 21, so we should have had it renewed
September 21st September 1st, 21 to run through August 30th 22. I don't
have an excuse other than say that it was missed.
The University of Louisville also did not invoice us, but again, it's on
us. It's on the office of safe, unhealthy neighborhoods to keep up with
our contracts and that was not performed appropriately.
and that was not performed appropriately
Therefore, this contract we are asking to run from September 1st, 2021
through December 15th, 2022,
the reason that we are asking it to run through the end of December or
the middle of December is because once we realized this contract was was
not renewed,
we discussed several several meetings discussion on whether the director
of an agency should be a metro employee. director of an agency should be
a metro employee
Or a professional service contract, and understanding that department of
health, they must have a professional service contract, because they need
a director that can run the health department, however,
in this position. Although Dr Williams has been instrumental in the
architecture of our balance prevention programs that we have implemented.
We really felt that it should be a metro employee.
Dr Williams was not interested in becoming a Metro.

Employee, she also has tenure with the university as you all know, she teaches at the university as well as several other projects that she oversees for the University.

Therefore, we decided to run this through December 15 to give Dr Williams enough time to transition.

And we are promoting a assistant director Callahan into the director's position. Paul's been with ocean for over.

A year and a half now very knowledgeable, and we asked Monique or Dr Williams if she would consider staying on through December 15th to be a senior advisor to Mr. as well as the ocean staff.

Thus I'm here and I'll be willing to answer any questions.

"Chair Dorsey"

I want to 1, thank you for the transparency. There's the reason why I'm a sponsor and I'm sure president James as well is because we understand there's not perfection in the system.

It means a lot to say. say

We missed it, we're owning the mistake and this is how we're going to correct it. And I am proud to sponsor legislation where there's transparency. I don't think we expect perfection. That's ridiculous.

But I do think we expect transparency and ownership. So, I, thank you for owning this.

I also, thank you for acknowledging the fact that we do want to have a full time that is accountable to local metro in regard to our violence prevention programs. And I think Dr Williams has done a.

Come on no job and I think we also understand with tenure you don't always want to leave that and being an African American woman with tenure university that is highly important.

So, I wouldn't take anything away from her not wanting to become a metro employee. That being said, I do support this. I'm appreciative of not having a direct cut off. So, that there is a transition.

Because knowledge is important, especially when it comes to violence prevention and what we are trying to do in this city. So.

Having that runway to transition all of that institutional knowledge from 1 person to another. Even though he's being promoted, having that director level knowledge in privy is important to the seamless transition of this.

So, I appreciate the structure of how this was done and the transparency to the public. I want to. Thank you for being an offering that transparency to us. Thank you so much. Thank you. Are there any other questions.

"President James"

thank you, Madam chair Thank you for being here. And I want to echo everything that chair Dorsey just spoke about.

Having the administration be very transparent about a mistake that was made seems pretty simple, but not always has it occurred. So I just want to say, thank you for doing that. I guess my other question is related to.

Whether consultants should run departments or not. Is that.

A administrative administration position on those particular items.

"Cathy Duncan"

I can't answer that with 100% specificity. I will say that it was an internal discussion that Chief golden Ella has and I had regarding the importance of a director, becoming a metro employee.

As I said, there are some instances as the health department where you have to contract with a professional, a doctor, but from our perspective, and I will say from chief golden to myself and chief has and we discussed with. discussed with

And.

Sorry, deputy mayor, Ellen Hassan, that this, this is the best that we feel we should do in this in this situation.

"President James"

Okay, thank you very much.

"Chair Dorsey"

Are there any additional questions? Councilman Kramer?

"Committee Member Kramer"

Thank you minister Kathy. I want to echo. What's been said all righty. So we'll just go back and say it again again, but we do appreciate you guys. Tackling this head on when you talk about hiring a new director, or promoting an individual to new director, and that being effective December, 15, um.

What what conversations have been had around.

What that position might look like going forward into the next year into into January of 23.

"Cathy Duncan"

The, the, the strengths of Mr Paul is.

30 years of implementation, 30 years of experience in setting up neighborhoods,

gang violence as well as CVS sites or similar programs to the site as well as he's a nationally known speaker on training for these these programs.

So, I would look for this program to expand even more so with his experience and his ability to now focus on.

Implementation as well, as running the department Additionally, he has a strong supervisory staff underneath of town. Very good staff as we've set often.

If you could meet every 1 of these ocean staff, you would be amazed at the commitment and the heart and soul.

They put into this program, I do know that we are talking about our, we are planning to transition the administration administrative function of.

To ocean Paul will be providing or ocean will be providing administrative support and staff and help with Mr. Jefferson but the overall program will continue to be run by the governance board.

That is the other item right now that we are looking to.

"Committee Member Kramer"

And what's Mr caroline's background with Julia Thank you for bringing that up. I was hoping to find a way to introduce that as a question. Um, what's Mr callaghans experienced with.

"Cathy Duncan"

He implemented with over the implementation of the site in Denver, Colorado.
